This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

Water use measurement conditions:

- a) The water user shall maintain and operate a totalizing flow meter, or other suitable measuring device as approved by the Director, in good working order, at each point of diversion.
- b) The water user shall allow the water master access to the meters or measuring devices; provided however, where the meters or measuring devices are located within a private structure, the Watermaster shall request access upon reasonable notice.

And said right shall be subject to all other conditions and limitations contained in said decree. The right to use water for the purposes aforesaid is restricted to the lands or place of use herein described.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered April 13, 2011, at Special Order Volume 83, Page 993, approving Transfer Application T-10311, and together with Certificate 87013, supersedes Certificate 56172, State record of Water Right Certificates.
