CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of MCKAY CREEK, A TRIBUTARY OF CROOKED RIVER for IRRIGATION of 3.0 ACRES.

This right was perfected under Permit S-3517. The date of priority is AUGUST 30, 1917. The amount of water to which such right is entitled and hereby confirmed for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.04 cubic foot per second, or its equivalent in case of rotation.

The point of diversion is located as follows:

13 S	16 E	WM	22	SE SW	LAFOLLETTE AND ALLEN DITCH – NORTH 78 DEGREES 20 MINUTES EAST, 2343 FEET FROM SW CORNER, SECTION 22

The use shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the lands under such right, and to which the water hereby confirmed is appurtenant is as follows:

The right to use of the water aforesaid hereby confirmed is restricted to the lands or place of use described.

The issuance of this superseding certificate does not confirm the status of the water right in regard to provisions of ORS 540.610 pertaining to forfeiture or abandonment.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This certificate is issued in accordance with OAR 690-380-6010(6) to describe the water right for a non-completed change in additional point of diversion approved by an order of the Water Resources Director entered JANUARY 12, 2001, at Special Order Volume 55, Page 21, approving Transfer Application T-6656, and together with Certificate 76674 and Certificate 98159, supersede Certificate 2428, State Record of Water Right Certificates.
