PURPOSE OR USE: MULTIPLE PURPOSE (INCLUDING BUT NOT LIMITED TO LIVESTOCK, FIRE PROTECTION AND FLOOD CONTROL)

MAXIMUM RATE: 3.0 ACRE-FEET (AF), BEING 1.0 AF IN HAMILTON 5 RESERVOIR AND 2.0 AF IN HAMILTON 7 RESERVOIR


The right to store and use the water for the above purpose is restricted to beneficial use at the place of use listed above.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This certificate is issued to confirm a change in CHARACTER OF USE approved by an order of the Water Resources Director entered September 16, 2016, at Special Order Volume 101, Page 890, approving Transfer Application T-12149, and together with Certificate 91886, supercedes Certificate 81452, State record of Water Right Certificates.
