CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

HOWARD L. BROWNSON MYRTLE CREEK, OR 97457

confirms the right to use the waters of the SOUTH MYRTLE CREEK, a tributary of SOUTH UMPQUA RIVER for IRRIGATION of 61.2 ACRES.

This right was perfected under Permit S-19302. The date of priority is MARCH 14, 1950. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.738 CUBIC FOOT PER SECOND, if available at the original point of diversion, NE ¼ NW ¼, as projected within H. Weaver DLC 39, Section 21, T29S, R4W, WM: 1,400 feet North and 3,200 feet West from E ¼ Corner, Section 21, or its equivalent in case of rotation, measured at the point of diversion from the stream.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year and shall conform to such reasonable rotation system as may be ordered by the proper state officer.
