CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

WOOLDRIDGE CREEK VINEYARD, LLC 818 SLAGLE CREEK ROAD GRANTS PASS, OR 97527

confirms the right to use the waters of TWO WELLS within the APPLEGATE RIVER BASIN, for IRRIGATION of 27.0 ACRES.

This right was perfected under Permit G-8331. The date of priority is AUGUST 14, 1978. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.15 CUBIC FOOT PER SECOND (CFS), BEING 0.105 CFS FROM WELL 1 AND 0.045 CFS FROM WELL 2 or its equivalent in case of rotation, measured at the point of diversion from the well.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-ONE HUNDRED SEVENTY-EIGHTH (1/178) of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 1.1 acre-feet per acre for each acre irrigated during the irrigation season of each year, and is further limited to an annual volume limitation of 29.7 acre-feet per year, and shall be further limited to appropriation of water only to the extent that it does not impair or substantially interfere with existing surface water rights of others, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

This is a final order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
