CERTIFICATE OF WATER RIGHT

confirms the right to the use of waters as limited and conditioned below. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the point of diversion from the source.

This right was confirmed by decree of the Circuit Court of the State of Oregon for HARNEY COUNTY. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 13, at Page 453.

SOURCE OF WATER: WEST FORK RATTLE SNAKE CREEK

PURPOSE OR USE: IRRIGATION OF 4.2 ACRES

DATE OF PRIORITY: 1886

That the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 3.0 acre-feet per acre during any year and the head of water shall not exceed 1.0 cubic foot per second for each 25 acres of land to be irrigated.

A description of the place of use is as follows:

Water use measurement conditions:

- a. The water user shall maintain the totalizing flow meter, or other suitable measuring device as approved by the Director, in good working order, at each point of diversion.
- b. The water user shall allow the Watermaster access to the meters or measuring devices; provided however, where the meters or measuring devices are located within a private structure, the Watermaster shall request access upon reasonable notice.

And said right shall be subject to all other limitations and conditions contained in said decree.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The right to the use of the water for irrigation purposes is restricted to the lands or place of use herein described.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered February 22, 2023, at Special Order Volume 127, Page 476, approving Transfer Application T-14032, and together with Certificate 96951, supercedes Certificate 14576, State record of Water Right Certificates.
