CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

WALLA WALLA RIVER IRRIGATION DISTRICT, successor to
FINIS IRRIGATION COMPANY, ET AL

confirms the right to use the waters of the WALLA WALLA RIVER, for IRRIGATION of 2,591.13 ACRES, DOMESTIC AND STOCK.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Umatilla County. The decrees are of record at Salem, in the Order Record of the Water Resources Director in Volume 12, at Page 9, and an Order of the Circuit Court of Umatilla County dated December 29, 1910, affirmed by the Oregon Supreme Court on October 5, 1912. The date of priority is 1888 and 1898.

The use is limited to 56.25 CUBIC FEET PER SECOND (CFS) WITH PRIORITY DATE 1888 AND 12.5 CFS WITH PRIORITY DATE 1898, or its equivalent in case of rotation, measured at the point of diversion from the Walla Walla River.

The point of diversion is located as follows:
