CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of A WELL in the DESCHUTES BASIN for IRRIGATION of 4.0 ACRES and STORAGE.

This right was perfected under Permit G-8566. The date of priority is JULY 31, 1978. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.07 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the well, provided further that in an event of a request for a change in point of appropriation, an additional point of appropriation or repair of this well, the quantity of water allowed herein together with any other right from this point of appropriation shall not exceed the capacity of this well at the time of perfection of this right.

The well is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

Water use measurement conditions:

- A. The water user shall maintain a totalizing flow meter or another suitable measuring device approved by the Director in good working order at each new point of appropriation.
- B. The water user shall allow the Watermaster access to the meter or measuring device; provided however, where the meter or measuring device is located within a private structure, the Watermaster shall request access upon reasonable notice.
- C. The water user shall keep a complete record of the amount of ground water withdrawn.

The quantity of water diverted at the new point of appropriation, shall not exceed the quantity of water lawfully available at the original point of appropriation described as follows:

Water shall be acquired from the same aquifer (water source) as the original point of appropriation.

The storage right shall be limited to 4.5 acre-feet per year to avoid enlargement.

The pond must be lined in order to keep the storage water in the pond for any large amount of time.

The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works shall be equipped with a useable access port, and may also include an air line and pressure gauge adequate to determine water level elevation in the well at all times.

The right to use water for the above purposes is restricted to beneficial use on the lands or place of use described.

This certificate is issued to confirm changes in POINT OF APPROPRIATION, PLACE OF USE and CHARACTER OF USE approved by an order of the Water Resources Director entered MARCH 6, 2015, at Special Order Volume 95, Page 191, approving Transfer Application T-11879, and together with Certificate 89881, supersedes Certificate 76811, State Record of Water Right Certificates.
