CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

RICK RODIG AND LYNDA RODIG LIVING TRUST DATED MARCH 22, 2002 PO BOX 397 MURPHY OR 97533

confirms the right to use the waters of the BOARD SHANTY CREEK, a tributary of APPLEGATE RIVER for SUPPLEMENTAL IRRIGATION of 0.6 ACRE.

This right was perfected under Permit No. 20800. The date of priority is OCTOBER 8, 1951. The amount of water to which such right is entitled for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.01 cubic foot per second or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 4.5 acrefeet per acre for each acre irrigated during the irrigation season of each year and use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

Land on which water is to be used is part of that described as follows: The West half of the North half of the SW¼ NW¼, Section 21, Township 37 South, Range 5 West, W.M. Also beginning at the NE Corner of SE¼ NE¼, Section 20, Township 37 South, Range 5 West, W.M.; and running thence South 460 feet; thence in a Northwesterly direction to a point on the North line of said SE¼ NE¼ which is 330 feet West of the point of beginning; then East 330 feet to the point of beginning.

This certificate supersedes Certificate 45052.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use described herein, and is subject to the existing minimum flow policies established by the Water Policy Board.
