The amount to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed a reasonable amount for domestic and stock use, and 0.27 CUBIC FOOT PER SECOND, for irrigation. The use shall conform to any reasonable rotation system ordered by the proper state officer.

Measurement, recording and reporting conditions:

- A. The water user shall maintain the totalizing flow meter or other suitable measuring device as approved by the Director in good working order, at each new point of diversion.
- The water user shall allow the watermaster access to the meters or measuring devices; provided however, where B. the meters or measuring devices is located within a private structure, the watermaster shall request access upon reasonable notice.

The water user shall operate and maintain the fish screen at the new points of diversion consistent with Oregon Department of Fish and Wildlife's operational and maintenance standard.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.

This certificate is issued to confirm a change in POINTS OF DIVERSION AND PLACE OF USE approved by an order of the Water Resources Director entered July 1, 2015, at Special Order Volume 96, Page 495, approving Transfer Application T-11948, supercedes Certificate 87644, State record of Water Right Certificates.
