CERTIFICATE OF WATER RIGHT

confirms the right to the use of water perfected under the terms of Permit G-10138. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the well(s). The specific limits and conditions of the use are listed below.

SOURCE OF WATER: WELL 2, WELL 3, WELL 4 AND WELL 5 IN POWDER RIVER BASIN

PURPOSE OR USE: SUPPLEMENTAL IRRIGATION OF 194.2 ACRES

MAXIMUM RATE: 2.43 CUBIC FEET PER SECOND (CFS), BEING 1.61 CFS FROM WELL 2 AND 0.82 CFS FROM WELL 3, 2.43 CFS FROM EITHER WELL 4 OR WELL 5, OR IN ANY COMBINATION NOT TOTALING MORE THAN 2.43 CFS

DATE OF PRIORITY: APRIL 18, 1983

The wells are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that in the event of a request for a change in point of appropriation, an additional point of appropriation or repair of this well, the quantity of water allowed herein together with any other right from this point of appropriation shall not exceed the capacity of this well at the time of perfection of this right. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

**NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW**

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The quantity of water diverted at the additional points of appropriation (Wells 4 and 5), together with that diverted at the old point(s) of appropriation (Well 2 and 3), shall not exceed the quantity of water available from the original point of appropriation (Well 2 and 3).

Water use measurement conditions:

- a. The water user shall maintain, in good working order, a totalizing flow meter or, with prior approval of the Director, another suitable measuring device at each new point of appropriation.
- b. The water user shall allow the Watermaster access to the meters or measuring devices; provided, however, where the meters or measuring devices are located within a private structure, the Watermaster shall request access upon reasonable notice.

Water shall be acquired from the same aquifer (water source) as the original point of appropriation.

The monitor the effect of water use from the wells authorized, the Department requires the water user to make and report annual static water-level measurements. The static water level shall be measured in the month of March. Reports shall be submitted to the Department within 30 days of measurement.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.

This certificate is issued to confirm an ADDITIONAL POINT OF APPROPRIATION approved by an order of the Water Resources Director entered May 27, 2014, at Special Order Volume 92, Page 632, approving Transfer Application T-11684, supercedes Certificate 52849, State record of Water Right Certificates.
