Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

- The water user shall maintain the totalizing flow meter or other suitable measuring device as approved by the A. Director in good working order, at each new point of appropriation.
- The water user shall allow the watermaster access to the meters or measuring devices; provided however, where В. the meters or measuring devices is located within a private structure, the watermaster shall request access upon reasonable notice.

Water shall be acquired from the same aquifer (water source) as the original points of appropriation.

The right to the use of the water for the purpose is restricted to beneficial use on the lands or place of use described.

This certificate is issued to confirm a change in POINTS OF APPROPRIATION approved by an order of the Water Resources Director entered April 21, 2023, at Special Order Volume 128, Page 141, approving Transfer Application T-13634, supercedes Certificate 60418, State record of Water Right Certificates.
