CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

HOCKETT FARMS INC.  
7746 SAINT PAUL HWY NE  
ST PAUL OR 97137

confirms the right to use the waters of TWO WELLS, a tributary of CHAMPOEG CREEK for IRRIGATION of 101.6 ACRES.

This right was perfected under Permit G-3357. The date of priority is JULY 1, 1966. The amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes and shall not exceed 1.27 cubic feet per second, or its equivalent in case of rotation, measured at the wells.

The wells are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre feet for each acre irrigated during the irrigation season of each year and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

This right does not constitute nor grant legal access onto or through another person's property for purposes of accessing the new point of appropriation.

**NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW**

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The quantity of water diverted at the additional point of appropriation (Well 2), together with that diverted at the original point of appropriation (Well 1), shall not exceed the quantity of water lawfully available at the original point of appropriation (Well 1).

Water shall be acquired from the same aquifer (water source) as the original point of appropriation.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.

This certificate is issued to confirm changes in ADDITIONAL POINT OF APPROPRIATION and PLACE OF USE approved by an order of the Water Resources Director entered OCTOBER 10, 2024, at Special Order Volume 133, Page 194, approving Transfer Application T-14238, supersedes Certificate 40577, State Record of Water Right Certificates.
