Measurement, recording and reporting conditions:

- A. The water user shall maintain the totalizing flow meter or other suitable measuring device as approved by the Director in good working order, at each point of appropriation (new and existing).
- B. The water user shall allow the watermaster access to the meters or measuring devices; provided however, where the meters or measuring devices is located within a private structure, the watermaster shall request access upon reasonable notice.

Water shall be acquired from the same aquifer (water source) as the original points of appropriation.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.

This certificate is issued to confirm a change in PLACE OF USE and ADDITIONAL POINTS OF APPROPRIATIONS approved by an order of the Water Resources Director entered November 27, 2018, at Special Order Volume 109, Page 1073, approving Transfer Application T-12819, supercedes Certificate 55574, State record of Water Right Certificates.
