The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the well(s). The specific limits and conditions of the use are listed below.

SOURCE OF WATER: WELLS 1, 2, 3, 4, 5, 11, 12, 13, 14, 15, A AND B IN THE MALHEUR LAKE BASIN

PURPOSE OR USE: IRRIGATION OF 343.0 ACRES

MAXIMUM RATE: 4.29 CUBIC FEET PER SECOND (CFS); FURTHER LIMITED TO 4.29 CFS FROM WELLS 1, 3, 4 AND 5, AND 3.32 CFS FROM WELL 2, 2.56 CFS FROM WELL 11, 2.04 CFS FROM WELL 12, 2.0 CFS FROM WELL 13, 1.93 CFS FROM WELL 14, 1.22 CFS FROM WELL 15, 1.26 CFS FROM WELL A AND 2.37 CFS FROM WELL B, OR IN ANY COMBINATION NOT TO EXCEED 4.29 CFS IN TOTAL

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The quantity of water diverted at the additional points of appropriations (Wells 2, 5, 11, 12, 13, 14, 15, A and B), together with that diverted at the original points of appropriations (Wells 1, 3 and 4), shall not exceed the quantity of water lawfully available at the original points of appropriations (Wells 1, 3 and 4).

Measurement, recording and reporting conditions:

- A. The water user shall maintain the totalizing flow meter or other suitable measuring device as approved by the Director in good working order, at each point of appropriation (new and existing), and shall keep a complete record of the amount of ground water withdrawn.
- B. The water user shall allow the watermaster access to the meters or measuring devices; provided however, where the meters or measuring devices is located within a private structure, the watermaster shall request access upon reasonable notice.

The works shall include an airline and pressure gauge or an access port for a measuring line, adequate to determine the water level elevation in the well at all times.

Water shall be acquired from the same aquifer (water source) as the original points of appropriation.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate is issued to confirm a change in PLACE OF USE and ADDITIONAL POINTS OF APPROPRIATIONS approved by an order of the Water Resources Director entered November 27, 2018, at Special Order Volume 109, Page1073, approving Transfer Application T-12819, supercedes Certificate 82391, State record of Water Right Certificates.
