The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the well. The specific limits and conditions of the use are listed below.

PURPOSE OR USE: SUPPLEMENTAL IRRIGATION OF 11.8 ACRES AND IRRIGATION OF 88.0 ACRES

MAXIMUM RATE: 0.7 CUBIC FOOT PER SECOND

DATE OF PRIORITY: JANUARY 30, 1975

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, should be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year and shall conform to such reasonable rotation system as may be ordered by the proper state officer.
