 CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO:

confirms the right to use the waters of the Little Walla Walla River, tributary to the Walla Walla River for IRRIGATION, DOMESTIC AND LIVESTOCK on 10.97 ACRES and IRRIGATION on 36.93 ACRES.

This right was perfected under by decree of the Circuit Court of the State of Oregon for Umatilla County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 12 at Page 9. The priority dates are 1874, 1881, 1882, 1890, 1891, 1893, 1894, 1895, 1901, 1903, 1904, 1905, 1906, and 1908.

The use is limited to 1.5 MINER'S INCHES PER ACRE, or 1.80 cubic feet per second, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:



The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
