confirms the right to the use of water perfected under the terms of Permit G-3556. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the well(s). The specific limits and conditions of the use are listed below.

SOURCE OF WATER: TWO WELLS A TRIBUTARY OF MCKENZIE RIVER

PURPOSE OR USE: MUNICIPAL

MAXIMUM RATE: 1.0 CUBIC FOOT PER SECOND

DATE OF PRIORITY: JANUARY 13, 1967

The quantity of water diverted at the additional point of appropriation (Well 2), together with the quantity diverted at the original point of appropriation (Well 1), shall not exceed the quantity of water lawfully authorized under the right.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

When required by the Department the water user shall install an in-flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.


Water shall be acquired from the same aquifer as the original point of appropriation.

The additional well shall not exceed a total depth of 138 feet below land surface.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject the existing minimum flow policies established by the Water Policy Board.

This certificate is issued to confirm an ADDITIONAL POINT OF APPROPRIATION approved by an order of the Water Resources Director entered April 14, 2003, at Special Order Volume 57, Page 427, approving Transfer Application T-9338, supercedes Certificate 46411, State record of Water Right Certificates.
