The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the well(s). The specific limits and conditions of the use are listed below.

SOURCE OF WATER: SCHOOL WELL, RUESSE WELL, AND RESERVOIR WELL IN THE DESCHUTES BASIN

PURPOSE OR USE: QUASI-MUNICIPAL USE

MAXIMUM RATE: 55.0 GALLONS PER MINUTE

DATE OF PRIORITY: MAY 6, 1981

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The quantity of water diverted at the additional points of appropriation (Ruesse Well and Reservoir Well), together with that diverted at the original point of appropriation (School Well), shall not exceed the quantity of water lawfully available at the original point of appropriation (School Well).

Water use measurement conditions:

- A. The water user shall maintain the totalizing flow meter, or, with prior approval of the Director, another suitable measuring device, in good working order at each point of appropriation (new and existing).
- B. The water user shall allow the Watermaster access to the meters or measuring devices; provided however, where the meters or measuring devices are located within a private structure, the Watermaster shall request access upon reasonable notice.

Water may be applied to lands which are not specifically described above, provided the holder of this right complies with ORS 540.510(3).

The water user shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record or amount of ground water withdrawn.

Water shall be acquired from the same aquifer (water source) as the original point of appropriation.

The right to the use of the water for the above purpose is restricted to beneficial use on the place of use described.

This certificate is issued to confirm an ADDITIONAL POINTS OF APPROPRIATION approved by an order of the Water Resources Director entered July 1, 2014, at Special Order Volume 92, Page 964, approving Transfer Application T-11731, supercedes Certificate 80614, State record of Water Right Certificates.
