confirms the right to the use of water perfected under the terms of Permit S-42470. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the point of diversion from the source. The specific limits and conditions of the use are listed below.

SOURCE OF WATER: AN UNNAMED SLOUGH, A TRIBUTARY OF POWDER RIVER

PURPOSE OR USE: SUPPLEMENTAL IRRIGATION OF 53.4 ACRES

MAXIMUM RATE: 0.86 CUBIC FOOT PER SECOND

DATE OF PRIORITY: APRIL 29, 1975

The point of diversion is located as follows:

7 S	39 E	WM	11	NE SW	450 FEET SOUTH AND 500 FEET WEST FROM C1/4 CORNER, SECTION 11

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitations allowed herein.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered October 24, 2016, at Special Order Volume 103, Page 250, approving Transfer Application T-12286, and together with Certificate 92005, supercedes Certificate 64145, State record of Water Right Certificates.
