CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

PACIFIC LIVESTOCK CO.
BURNS, OR 97720

confirms the right to use the waters of (see below), for IRRIGATION of 4733.2 ACRES and SUPPLEMENTAL IRRIGATION of 4.9 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for MALHEUR County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 8, at Page 228. See below for the dates of priority.

A description of the place of use to which this right is appurtenant is as follows:

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1.5 ACRE-FEET PER ACRE IN ANY 30 DAY PERIOD PRIOR TO JUNE 1, 1.0 ACRE-FOOT PER ACRE IN ANY 30 DAY PERIOD AFTER JUNE 1 OF EACH YEAR, OR 3.0 ACRE-FEET PER ACRE DURING ANY SEASON, DIVERTED AT A RATE NOT TO EXCEED 1/20 (ONE-TWENTIETH) OF CUBIC FOOT PER SECOND PER ACRE; AND 5.0 CUBIC FEET PER SECOND FOR 120 ACRES IN SECTION 31, T 20 S, R 36 E, WM., or its equivalent in case of rotation, measured at the point of diversion from the source.
