CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

BRAD ALLEN

confirms the right to use the waters of TWO WELLS in the WILLIAMS CREEK BASIN for SUPPLEMENTAL IRRIGATION of 156.6 ACRES.

This right has been perfected under Permit G-7917. The date of priority is DECEMBER 27, 1977. The right is limited to not more than 1.95 CUBIC FEET PER SECOND (CFS), FURTHER LIMITED TO 1.95 CFS FROM WELL 1 AND 1.25 CFS FROM WELL 2, NOT TO EXCEED A CUMULATIVE TOTAL OF 1.95 CFS FROM THE WELLS IN ANY COMBINATION, or its equivalent in case of rotation, measured at the wells.

The wells are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The quantity of water diverted at the additional point of appropriation, together with that diverted at the original point of appropriation, shall not exceed the quantity of water lawfully available at the original point of appropriation.

Water shall be acquired from the same aquifer (water source) as the original point of appropriation.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate is issued to confirm a change in ADDITIONAL POINT OF APPROPRIATION approved by an order of the Water Resources Director entered MARCH 20, 2014, at Special Order Volume 91, Page 1018, approving Transfer Application T-11665, supersedes Certificate 60027, State Record of Water Right Certificates.
