NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The quantity of water diverted at the additional point of appropriation (BRIGGS 2), together with that diverted at the original point of appropriation (CROW WELL), shall not exceed the quantity of water lawfully available at the original point of appropriation (CROW WELL).

Water shall be acquired from the same aquifer (water source) as the original point of appropriation.

Water use measurement conditions:

- A. The water user shall maintain the totalizing flow meter, or, with prior approval of the Director, another suitable measuring device, in good working order at each point of appropriation, (new and existing).
- B. The water user shall allow the Watermaster access to the meters or measuring devices; provided however, where the meters or measuring devices are located within a private structure, the Watermaster shall request access upon reasonable notice.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.

This certificate is issued to confirm a change in PLACE OF USE and AN ADDITIONAL POINT OF APPROPRIATION approved by an order of the Water Resources Director entered September 26, 2023, at Special Order Volume 129, Page 114, approving Transfer Application T-13925, supercedes Certificate 32394, State record of Water Right Certificates.
