CERTIFICATE OF WATER RIGHT

confirms the right to the use of water perfected under the terms of Permit G-4030. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the well(s). The specific limits and conditions of the use are listed below.

SOURCE OF WATER: A WELL IN SILVIES RIVER BASIN

PURPOSE OR USE: IRRIGATION OF 17.9 ACRES

MAXIMUM RATE: 0.22 CUBIC FOOT PER SECOND

8DATE OF PRIORITY: MARCH 18, 1968

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year; and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

Water use measurement conditions:

- A. The water user shall maintain the totalizing flow meter or other suitable measuring devices as approved by the Director in good working order at each point of diversion (new and existing).
- B. The water user shall allow the Watermaster access to the meters or measuring devices; provided however, where the meters or measuring devices are located with a private structure, the watermaster shall request access upon reasonable notice.

The quantity of water diverted at the new point(s) of appropriation (Briggs 2), shall not exceed the quantity of water lawfully available from the original point of appropriation described as follows:

Water shall be acquired from the same aquifer (water source) as the original point of appropriation.

The right to the use of the water for the purposes is restricted to lands or place of use herein described.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered June 16, 2025, at Special Order Volume 134, Page 981, approving Transfer Application 14340, supercedes Certificate 97383, State record of Water Right Certificates.
