CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

FRANK E. PRICE and H. R. NEHRBAS
SUNNY VALLEY, OR 97478

confirms the right to use the waters of GRAVE CREEK, a tributary of ROGUE RIVER for the purpose of IRRIGATION of 6.0 ACRES for Tract No. 1 and 11.4 ACRES for Tract No. 2 and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Josephine County, and the said decree entered of record at Salem, in the Order Record of the Water Resources Director in Volume 4, at page 1: that the priority of the right thereby confirmed dates from 1891 for Tract No. 1, and 1863 for Tract No. 2.

That the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.10 cubic foot per second for Tract No. 1, and 0.19 cubic foot per second for Tract No. 2.

The points of diversion are located as follows:


