CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of WELL 2, A TRIBUTARY TO SILVIES RIVER, for SUPPLEMENTAL IRRIGATION of 90.1 ACRES.

This right was perfected under Permit G-5077. The date of priority is JUNE 10, 1970. The amount of water to which such right is entitled and hereby confirmed for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.13 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the well.

The point of diversion from the well is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

**NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW**

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered JULY 3, 2024, at Special Order Volume 131, Page 497, approving Transfer Application T-14155, and together with Certificate 97665, supersedes Certificate 46974, State Record of Water Right Certificates.
