CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

VALE RANCHES LLC
1606 AMARAL COURT
FAIRFIELD CA 94534

confirms the right to use the waters of THREE WELLS, tributary to BUCK CREEK BASIN (LOST RIVER BASIN) for IRRIGATION of 199.4 ACRES.

This right was perfected under Permit G-1790. The date of priority is MARCH 8, 1961. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 2.49 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of appropriation.

The wells are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

Water use measurement conditions:

- A. The water user shall maintain the totalizing flow meter or other suitable measuring device as approved by the Director in good working order at each point of appropriation.
- B. The water user shall allow the Watermaster access to the meters or measuring devices; provided however, where the meters or measuring devices are located within a private structure, the Watermaster shall request access upon reasonable notice.

The quantity of water diverted at the additional points of appropriation, together with that diverted at that original point of appropriation, shall not exceed the quantity of water lawfully available at the original point of appropriation.

Water shall be acquired from the same aquifer (water source) as the original point of appropriation.

When required by the Department, the water user shall install and maintain an in-line flow meter or other suitable measuring device for measuring and recording the quantity of water appropriated. The type and plans of measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works shall be equipped with a useable port, and may also include an air line and pressure gauge to determine the water level elevation in the well at all times.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered APRIL 30, 2020, at Special Order Volume 116, Page 596, approving Transfer Application T-12762, supersedes Certificate 87991, State Record of Water Right Certificates.
