confirms the right to the use of water perfected under the terms of Permit S-37246. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the point of diversion from the source. The specific limits and conditions of the use are listed below.

SOURCE OF WATER: UNNAMED STREAM A TRIBUTARY OF TEAL CREEK

PURPOSE OR USE: DOMESTIC USE FOR ONE FAMILY

MAXIMUM RATE: SHALL NOT EXCEED 0.1 ACRE-FOOT OF WATER

PERIOD OF USE: APRIL 1 TO SEPTEMBER 30 OF EACH YEAR

DATE OF PRIORITY: SEPTEMBER 20, 1972

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This certificate is issued to confirm a change in PLACE OF USE AND CHARACTER OF USE approved by an order of the Water Resources Director entered September 26, 1995, at Special Order Volume 49, Page 328, approving Transfer Application T-7359, and together with Certificate 68609, supercedes Certificate 47950, State record of Water Right Certificates.
