confirms the right to the use of waters as limited and conditioned below. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the point(s) of diversion from the source.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Baker County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 8, at Page 134.

SOURCE OF WATER: STRAW RANCH CREEK FOR TRACT #1 AND ALDER CREEK FOR TRACT #2

PURPOSE OR USE: IRRIGATION

DATE OF PRIORITY: 1862 FOR TRACT #1 AND 1864 FOR TRACT #2

The amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 3.0 acre-feet per acre during any irrigation season (with the further limitations contained in Paragraph 64 of said decree).

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The quantity of water diverted at the new points of diversion, combined with that diverted from the original point of diversion, shall not exceed the quantity of water lawfully available at the original points of diversion, described as follows:

The Director may require the water user to install a totalizing flow meter or other suitable measuring devices at each point of diversion. If the Director notifies the water user to install totalizing flow meters or other measuring devices, the water user shall install such devices specified by the Director within the period allowed in the notice. Once installed, the water user shall maintain the meters or measuring devices in good working order and shall allow the Watermaster access to the meters or measuring devices.

When required by the Department, the water user shall install, maintain and operate a headgate to control and regulate the quantity of water diverted. The types of plans of the headgate must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

The water user shall maintain and operate the fish screen and/or by-pass device, as appropriated, at Troy #2 point of diversion consistent with Oregon Department of Fish and Wildlife's operational and maintenance standards.

Said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for irrigation purposes is restricted to lands or place of use herein described.

This certificate is issued to confirm a change in PLACE OF USE AND ADDITIONAL POINT OF DIVERSIONS approved by an order of the Water Resources Director entered July 20, 2012, at Special Order Volume 88, Page 216, approving Transfer Application T-10961, and together with Certificate 87092, supercedes Certificate 6042, State record of Water Right Certificates.
