confirms the right to the use of water perfected under the terms of Permit S-49406. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the point(s) of diversion from the source. The specific limits and conditions of the use are listed below.

SOURCE OF WATER: UNNAMED SLOUGH, A TRIBUTARY OF EAST FORK SILVIES RIVER

PURPOSE OR USE: SUPPLEMENTAL IRRIGATION OF 9.2 ACRES

MAXIMUM RATE: 0.12 CUBIC FOOT PER SECOND

DATE OF PRIORITY: JUNE 5, 1985

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that although declared herein to be for supplemental irrigation, the right may, in the interest of conserving the ground water supplies, be exercised at times when water is available in the ground water supply appropriated under the right perfected under Permit G-10512, provided that the total quantity diverted from both sources of supply shall not exceed the limitation allowed herein.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

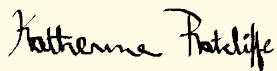

The water user shall maintain and operate the existing measurement device and shall make such improvements as may be required by the Department.

The right to the use of the water for the above purpose is restricted to beneficial use on the place of use described.
