under Enlargement Permit No. 148 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon and duly confirmed by order of the STATE WATER BOARD of Oregon, made and entered
of record in the Record of Proceedings of said Board, ut Salem, in Volume 1,
at page 205 , on the17th day of November, 1915 ; that the priority of
the right hereby confirmed dates from July 29, 1912 ; that the amount of
water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not
exceed 0.25 cubic foot per second, or its equivalent in case of rotation. The use hereunder shall conform to any reasonable rotation system ordered by the proper State Officer Al description of the lands under such right, and to which the water hereby
confirmed is appurtenant, or, if for other purposes, the place where such water is put to beneficial use, is as follows:
west quarter of Northwest quarter; Section Six (6), Township Two (2) South, Range Thirteen (13) East of Willemette Meridian, in Wasco County, Oregon.
The right to the use of the water aforesaid hereby confirmed is restricted to the lands or place of use herein described.
Rights to the use of water for power purposes are limited to a period of forty years from the date of priority of the right, as herein set forth, subject to a preference right of renewal under the laws existing at the date of the expiration of the right for power purposes, as hereby confirmed and limited.
