
KNOW ALL MEN BY THESE PRESENTS, that we W.G. Smith & Florence D. Smith, his wife, of Lane Co. Ore. do hereby declare, certify and acknowledge that the within plat of a portion of the NE 1/4 of the NE 1/4 of the NE 1/4 of the NW 1/4 of Sec 22, T33S, R6W, M. a portion of the SW 1/4 of the SE 1/4 of the SE 1/4 of the SW 1/4 of Sec 15, T33S, R6W, M. Willamette Meridian, to be known as WOLF CREEK, Ore. being a replat of the original Townsite of Wolf Creek, Ore. plat of which is on file with the County Clerk of Josephine Co. containing 38 Acres more or less, with Tract 86 of Wolf Creek Orchard Tracts, containing 8 Acres more or less, added, as Block F and more definitely described as follows: Beginning at a point 310 ft. S. of N.W. Corner of NE 1/4 of NW 1/4 Sec 22, T33S, R6W, W.M. thence S. 410 ft. to Wolf Creek, thence following Wolf Creek in an easterly and northeasterly direction to intersection of Southern Pacific Ry. 2947 ft. thence West 2202 ft. along S.P. Ry. Right of Way to quarter section line 21 ft. S. of 1/4 corner above mentioned, thence 289 ft. to starting point, containing 38 Acres, more or less, is a true and correct map of said premises, as the same has been surveyed and platted, and that it correctly indicates the corners, lines and dimensions of the streets and lots thereon, that we hereby dedicate to the County of Josephine, State of Oregon, for public use any and all streets shown by the within map, and by the affidavit of Survey hereto annexed.

Approval of Survey.
I, R.A. Dear, being just duly sworn, depose and say, that at the request of W.G. Smith and Florence D. Smith his wife, I did on the 14 day of May 1913 AD begin and survey and subdivide into blocks, lots and streets the following described premises, to-wit: Beginning at a point 310 ft. S. of NW. corner of NE 1/4 NW 1/4 Sec 22, T33S, R.6W, W.M. thence S. 410 ft to Wolf Creek, thence following Wolf Creek 2947 ft in an easterly and north-easterly direction to the intersection with the Southern Pacific Ry Right of Way, thence West 2202 ft to L.S. line above mentioned, 21 ft S of 1/4 corner, thence S. 289 ft. to starting point, containing in all, 38 Acres, more or less. The initial point of this survey is identified by an iron rod 2.5 ft set in the ground. That subsequent to the survey, I caused to be drafted the within plat of the same on a scale of 100 ft to the inch to indicate the survey and designate the lands as now subdivided and present for approval. That the blocks as lettered and lots as numbered are correct as herein indicated.
