

CERTIFICATE of SURVEYOR

I, J. M. Morgan, being first duly sworn, depose and say, that I have surveyed and marked with proper monuments the lands shown on the annexed plat of which the following is a correct and true description:

Beginning at the Initial Point, a 2"x36" galv. iron pipe set 6" below the ground surface, from which the N.W. corner of Section 14, T. 27 S., R. 6 W., W. M., Douglas County, Ore. bears N 0° 45' W - 448.7 ft. and S 89° 25' W - 128.0 ft., thence running along the South line of the Calkins Road N 89° 25' E - 1326.5 ft. to an iron pipe, thence leaving said road and running S 0° 45' E - 802.7 ft. to an iron pipe, thence N 89° 25' E - 288.0 ft. to an iron pipe, thence S 1° 00' W - 190.0 ft. to a point on the center line of the South Umpqua River, thence following said center line downstream N 49° 00' W - 590.0 ft., N 56° 30' W - 454.0 ft., N 67° 00' W - 249.0 ft., N 81° 15' W - 205.0 ft., thence leaving said center line of said river and running N 0° 45' E - 1124.5 ft. to an iron pipe, thence S 89° 25' W - 329.0 ft. to an iron pipe, thence N 0° 45' W - 802.7 ft. to the place of beginning, all located in Sec. 14, T. 27 S., R. 6 W., W. 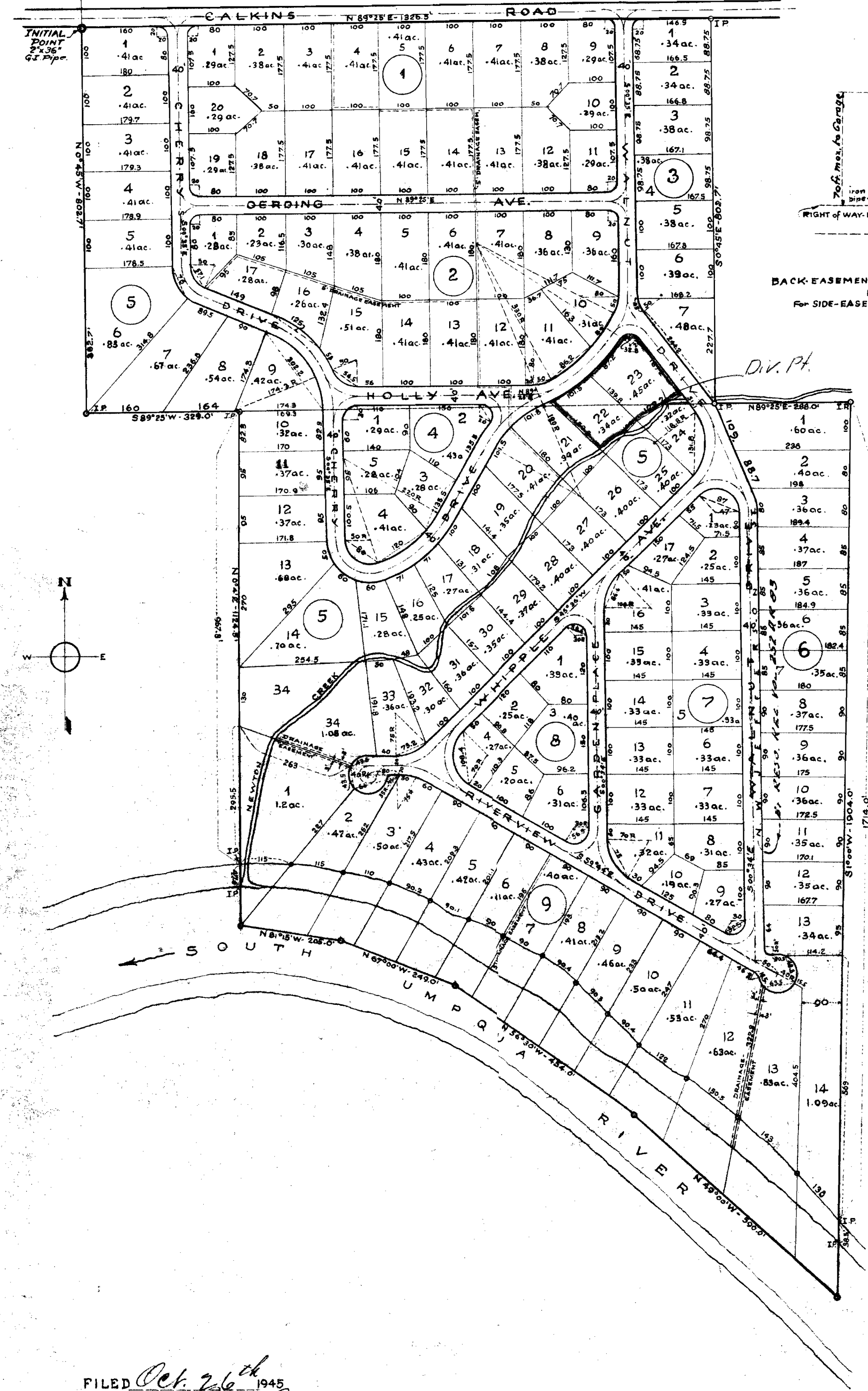
