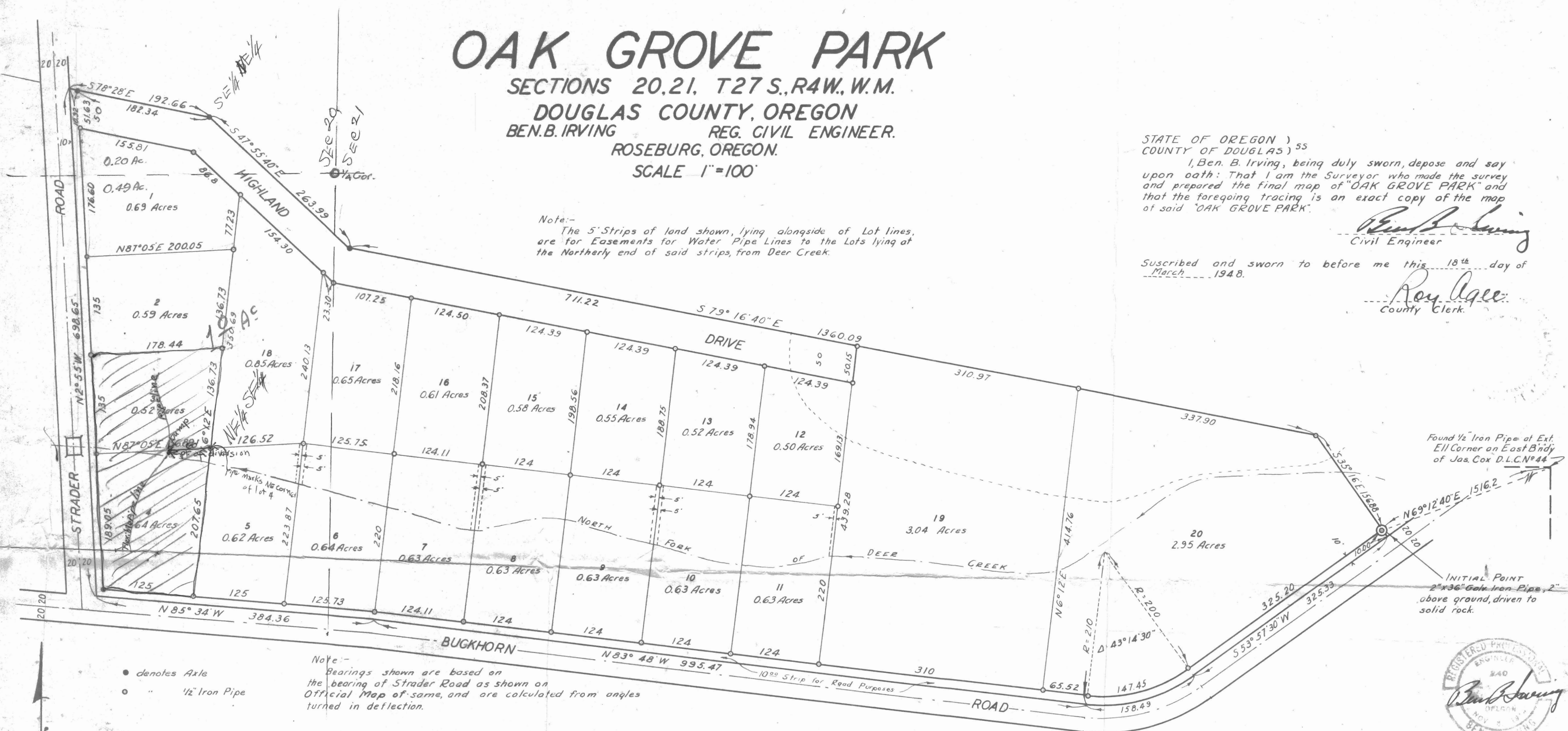

Irving, being first duly sworn, depose and say that I have correctly surveyed and marked with proper monuments the lands delineated on the annexed plat, of which the following is a true and correct description: - Beginning at a 2" x 36" Galv. Iron Pipe, 2" above ground, and driven to solid rock, from which pipe the Exterior E.I. Corner on the East boundary of the Jas. Cox D.L.C. No. 44, T27S., R4W., W.M. bears N69°12'40"E 1516.2'; Thence S35°16'E 10.00' to a point on the North boundary of Buckhorn Road; Thence following said boundary S53°57'30"W 325.32 ft. to the beginning of a curve to the right, having a radius of 210.00 ft. and a central angle of 43°14'30"; Thence along said curve 158.22 ft. to the end thereof; Thence N83°48'W 995.47 ft. and N85°34'W 384.35 ft. to the intersection of said North boundary with the East boundary of Strader Road; Thence N2°55'W 698.65 ft. along said East boundary; Thence S78°28'E 10.22 ft. to an axle, and 182.34 ft. to an axle; Thence S47°55'40"E 263.22 ft. to an axle; Thence S79°16'40"E 711.22 ft. to a 1/2" I.P. and 310.22 ft. to a 1/2" I.P. and 337.22 ft. to a 1/2" I.P.; Thence S35°16'E 156.22 ft. to the point of beginning; - containing 21.22 Acres, more or less in Sections 20, and 21, T27S., R4W., W.M., Douglas County, Oregon.
