### DESCRIPTION

Beginning at a point on the South line of Section 23 in Township 19 South, Range 12 West of the Willamette Meridian 420.42 feet South 89°13' East from the Southwest Corner thereof and running North 509.45 feet to the Shore line of Woodhink Lake, thence along the shore line of said lake as follows South 86°03' East 100.0 feet, North 80°38' East 99.16 feet, North 81°20' East 43.79 feet, North 31°13' East 60.9 feet, North 45°07' East 63.64 feet, North 42.1 feet, North 26°44' East 70.9 feet, North 21°17' West 112.18 feet, North 5°55' West 106.63 feet, North 27°42' East 77.29 feet, North 10°41' West 100.0 feet, North 7°19' West 91.19 feet, North 58°49' East 156.41 feet, North 70°23' East 101.13 feet, North 60°07' East 87.30 feet, North 46°40' East 101.27 feet, South 84°33' East 110.0 feet, North 44°16' East 68.75 feet, North 76°10' East 100.0 feet, North 53°05' East 102.1 feet, and North 36°36' East 94.24 feet, thence South 30°54' East 326.73 feet, thence South 26°50' East 387.87 feet to the Northerly Right of Way line of County Road No. 1174, thence along said Right of Way line as follows South 47°37' West 640.36 feet, around the arc of a 985.0 feet radius curve (the long chord of which bears South 38°18' West 318.92 feet) a distance of 320.30 feet, and South 28°59' West 368.40 feet to the South line of Section 23 said Township and Range, thence North 89°13' West along said South line 568.15 feet to the place of beginning, in Lane County, Oregon.

### SURVEYOR'S AFFIDAVIT

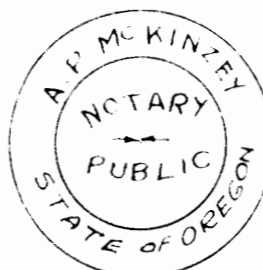
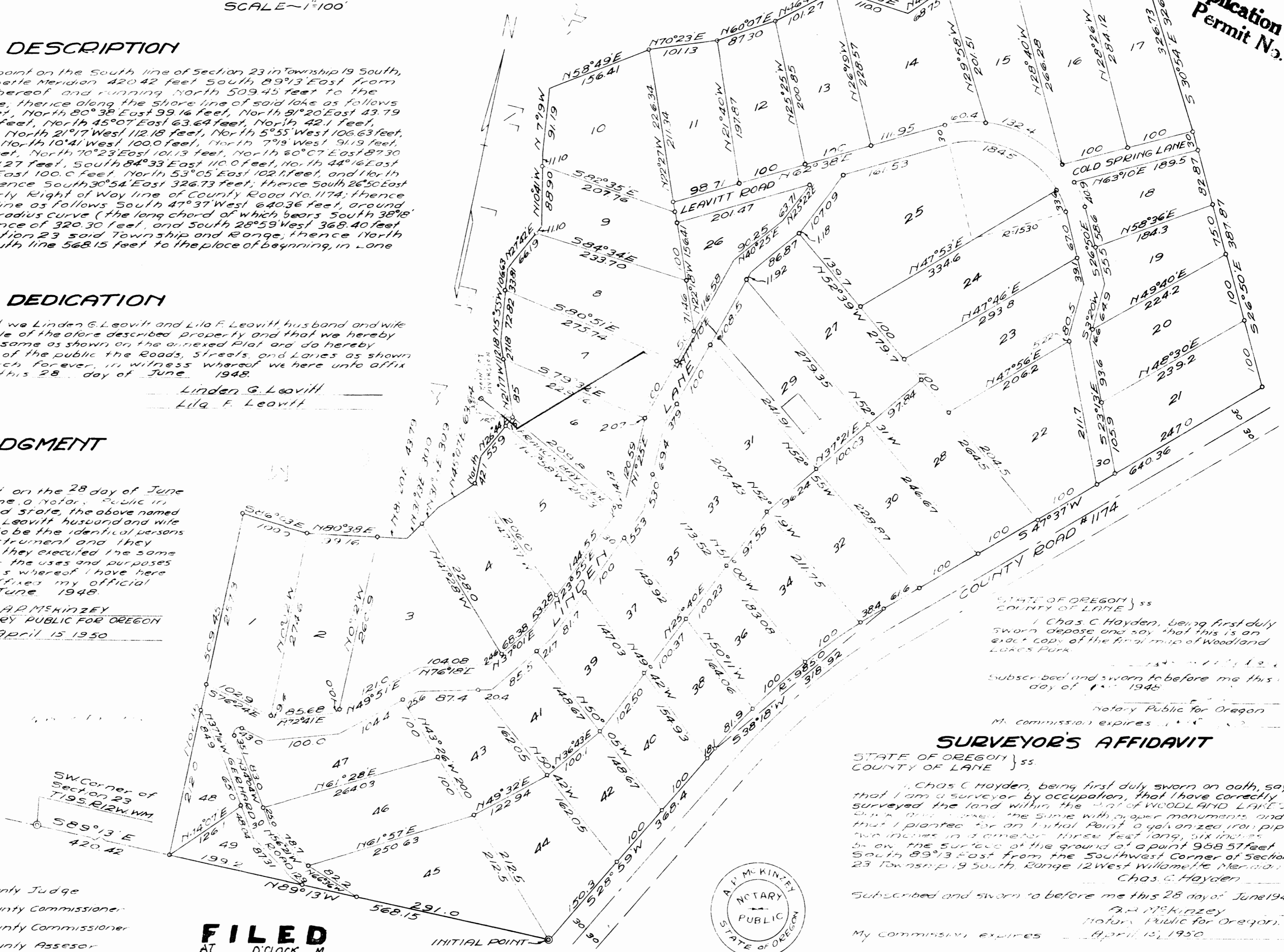
