I further certify that the lands may be described as follows: beginning at a point on the north line of said sec. 10, said point being S. 89° 08' 06" W. and 418.43 feet from the N.E. cor. of said sec. 10, said point being the center line of Tumalo Creek; thence S. 89° 08' 06" W. - 152.437 feet, thence S 0° 08' 02" E. 945.43 ft to the center line of Tumalo Creek; thence Northerly along the center line of Tumalo Creek as the plat shows, to an intersection with said north line of sec. 10, which is the point of beginning.
