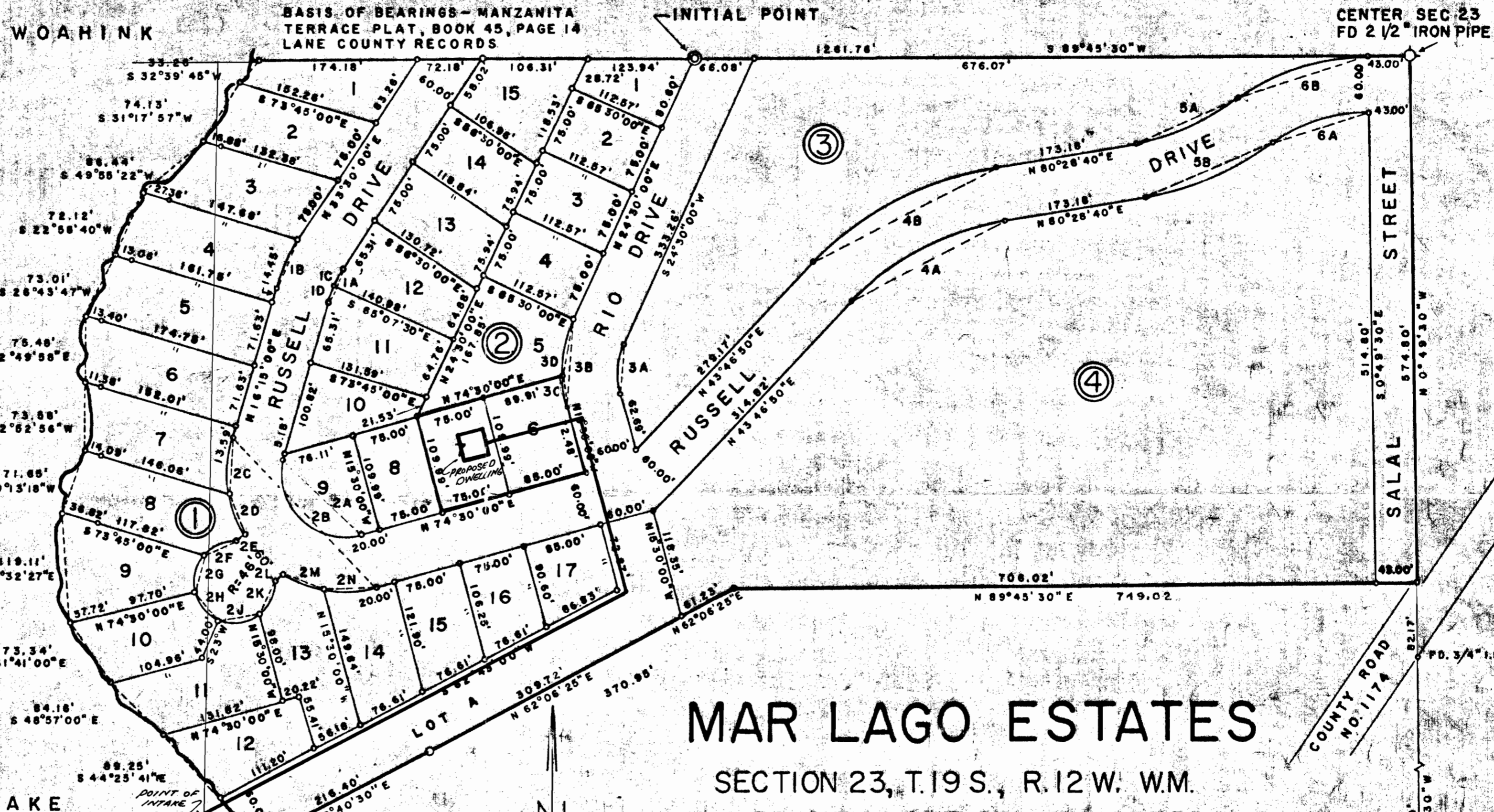


**DESCRIPTION**

BEGINNING AT THE CENTER OF SECTION 23 IN TOWNSHIP 19 SOUTH; RANGE 12 WEST OF THE WILLAMETTE MERIDIAN; THENCE SOUTH 0°49'30" EAST 374.8 FEET TO THE NORTHERLY EDGE OF COUNTY ROAD NO. 1174; THENCE SOUTH 89°45'30" WEST 749.02 FEET; THENCE SOUTH 62°06'25" WEST 370.95 FEET; THENCE SOUTH 62°40'30" WEST 216.4 FEET TO A POINT ON THE SHORE OF WOAHINK LAKE; THENCE FOLLOWING THE SHORE OF WOAHINK LAKE IN A NORTHERLY DIRECTION TO A POINT BEARING SOUTH 89°45'30" WEST FROM THE POINT OF BEGINNING; THENCE NORTH 89°45'30" EAST TO THE POINT OF BEGINNING, ALL IN DUNES CITY, LANE COUNTY, OREGON.

NOTE - THE LINES OF LOTS ADJACENT TO WOAHINK LAKE EXTEND TO THE LOW WATER MARK AND ALL RIPARIAN RIGHTS TO THE PORTION OF THE LAKE ABUTTING SAID LOTS ARE ATTACHED THERETO
