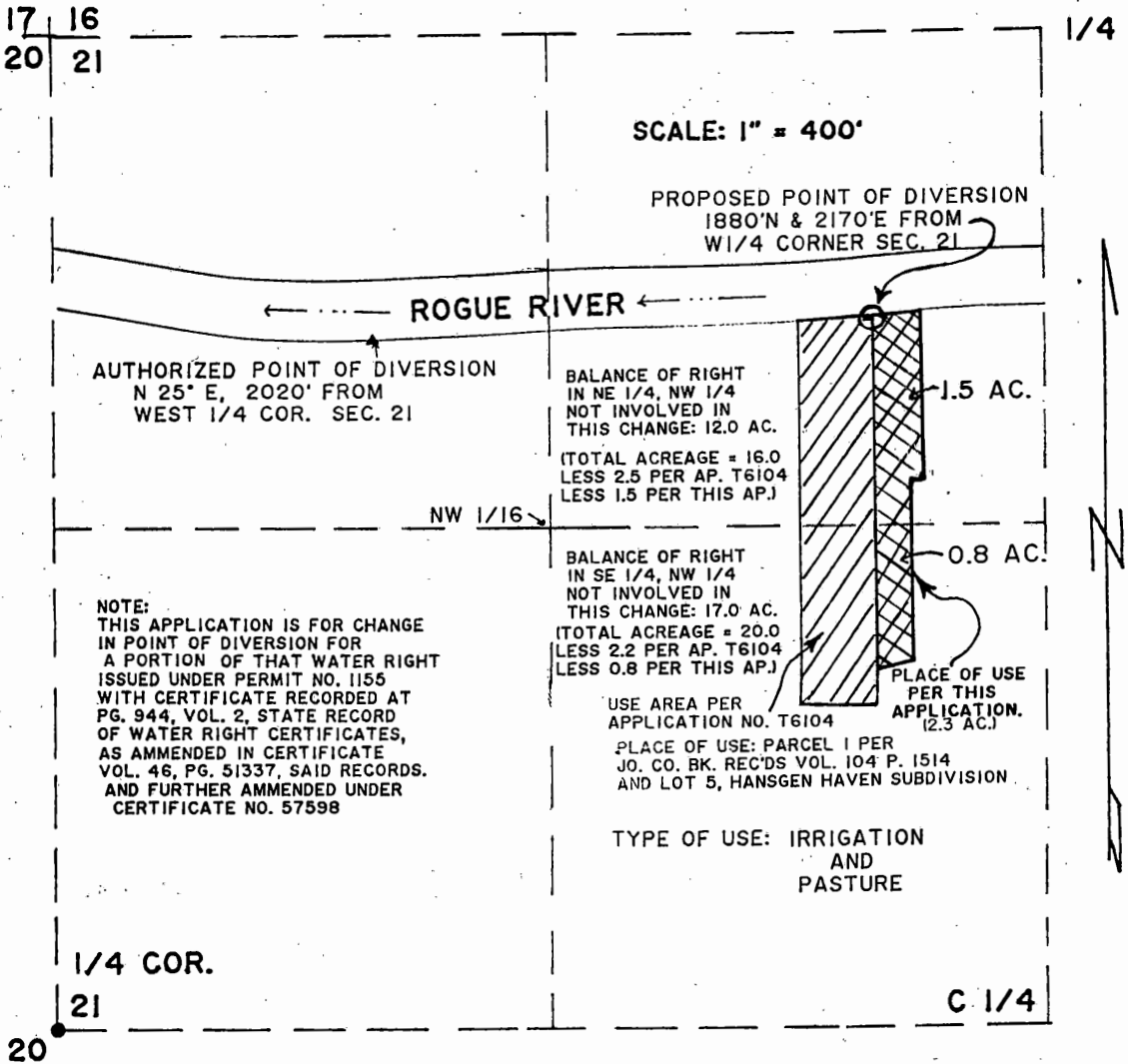

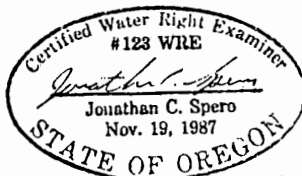

TRANSFER APPLICATION

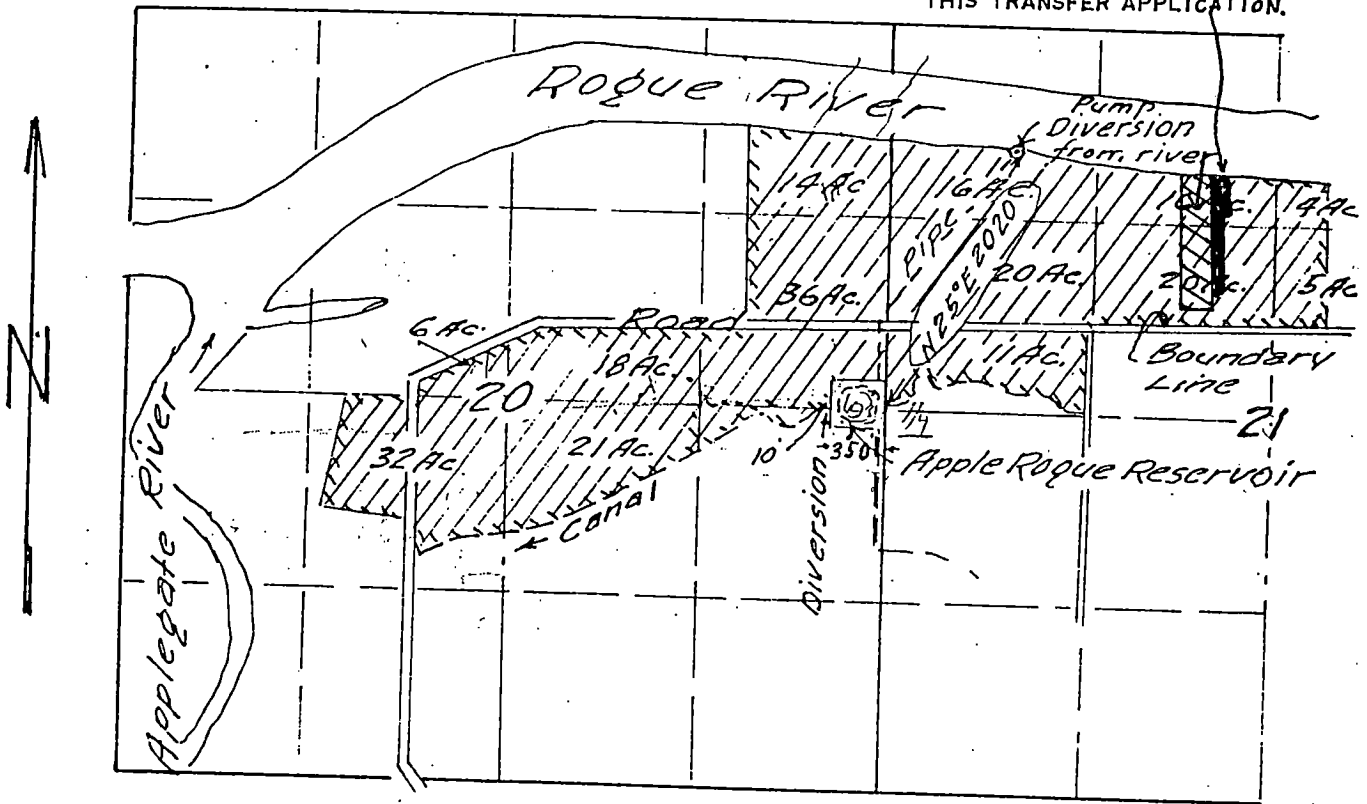

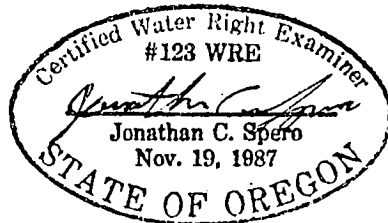
