






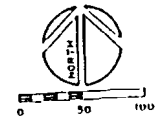


-  FILL WITHIN 100 YEAR FLOOD PLAN OUTSIDE OF DELINEATED WETLAND

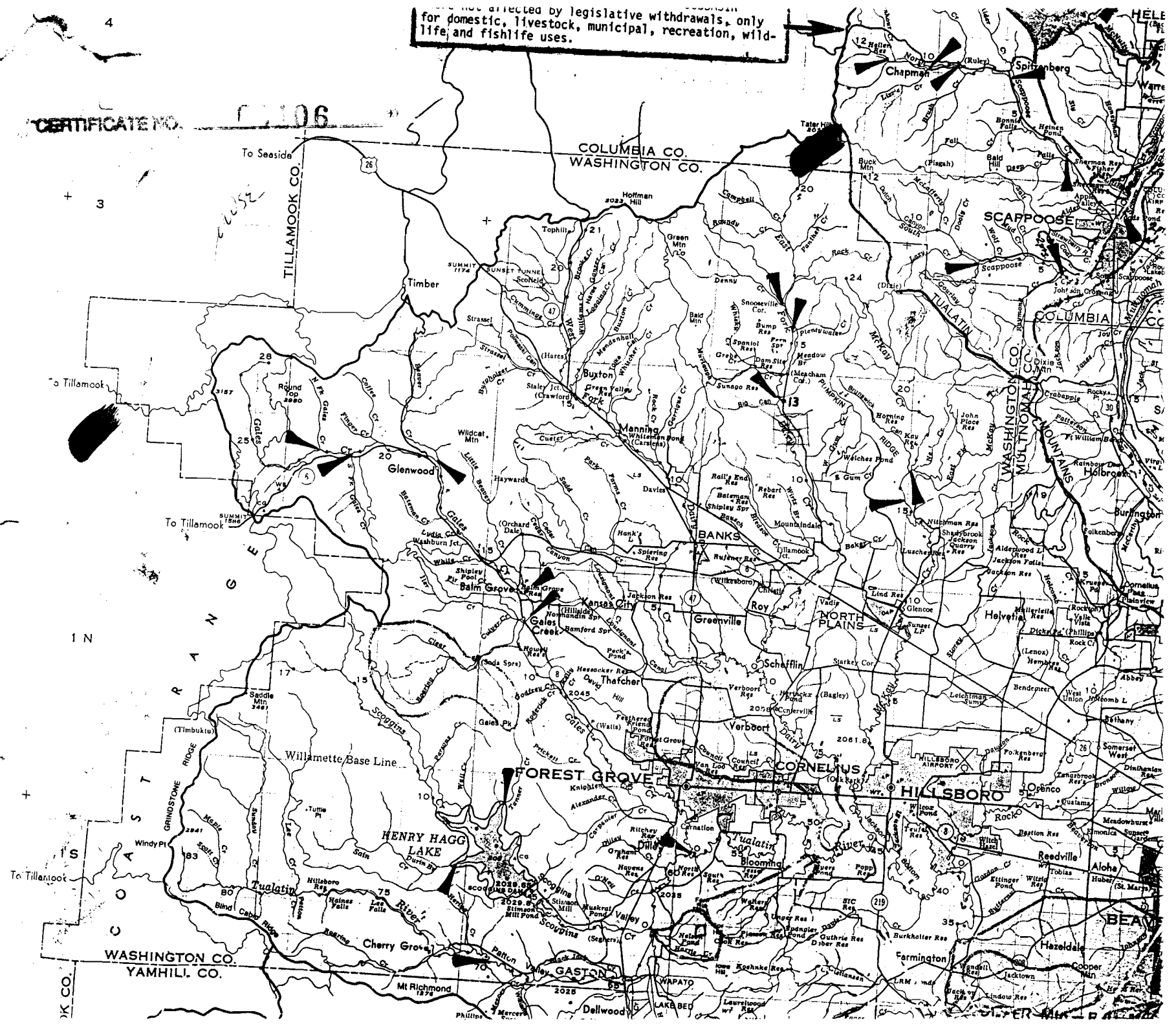
