 SECTION A

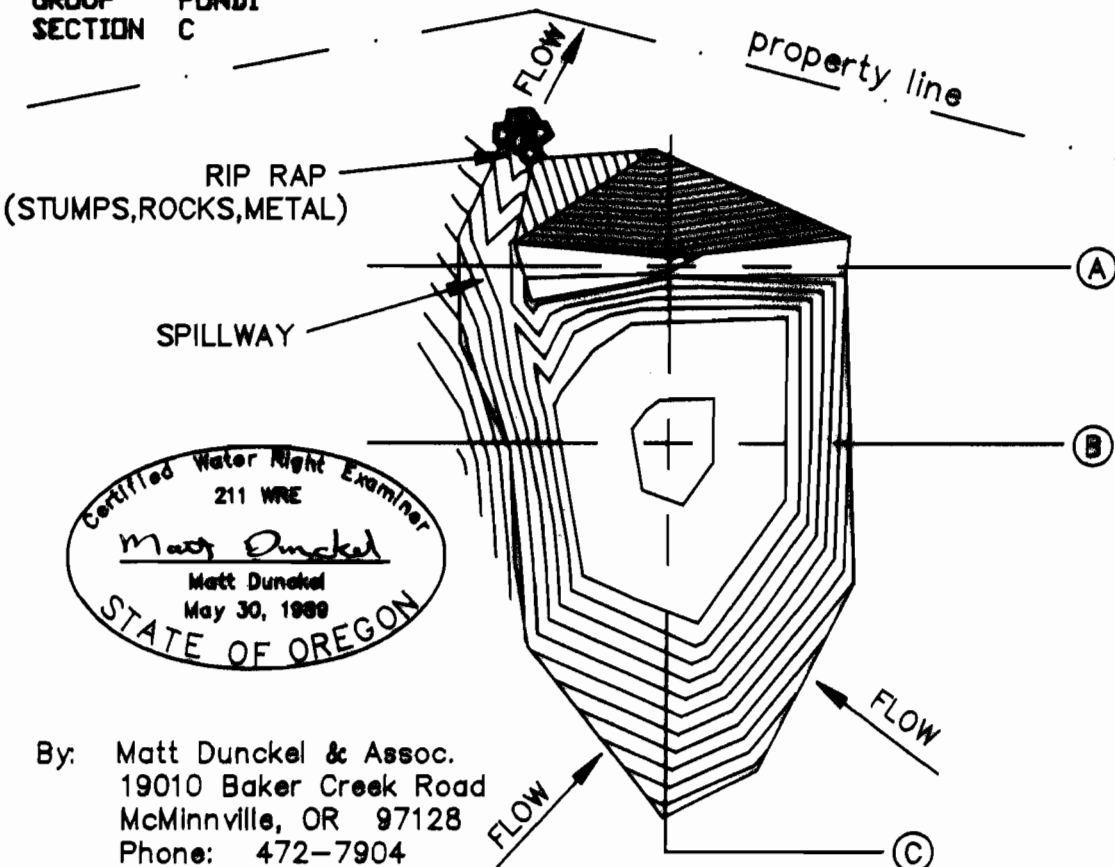

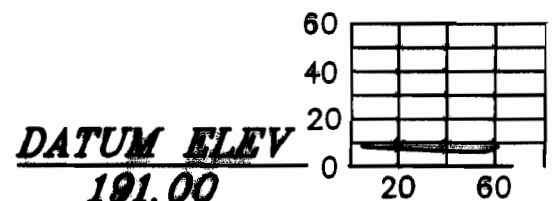
GROUP POND2

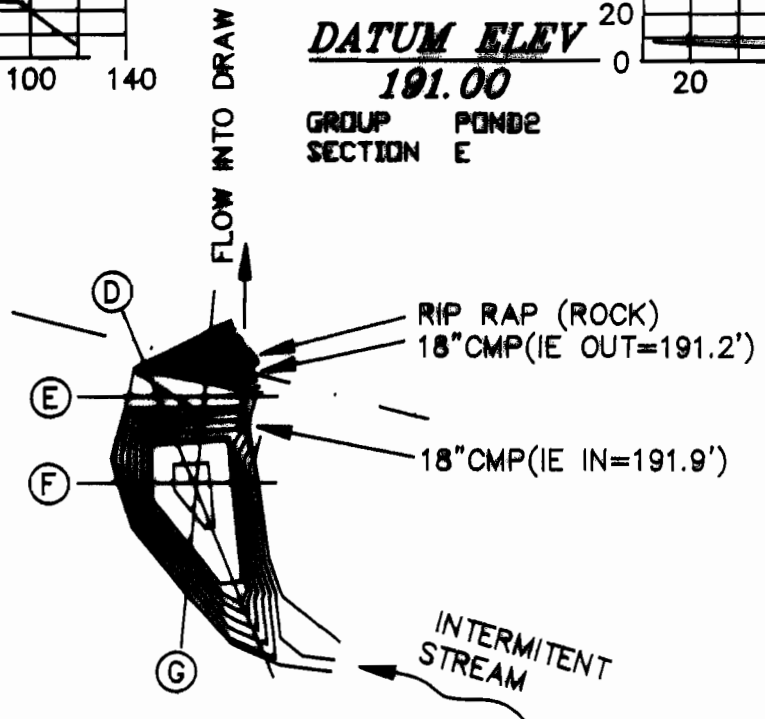
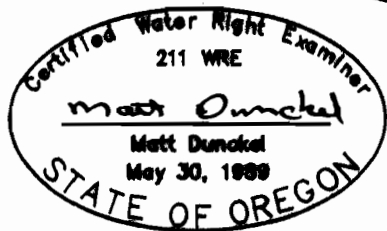
