




NOTE: The original drawing for the point of diversion shows the springs situated in NE 1/4. SW 1/4 of Sect. 32. The drawing also shows Goose Creek running through the West 1/2 of the Southeast 1/4. The U.S.G.S maps all show this to be incorrect, and that Goose Creek actually runs through the West 1/2 of the SW 1/4 of Section 33. I visited the site and found that the springs do in fact lay as I have shown them. In my opinion the original drawing is not accurate. My observations while on the site would indicate that the springs could not have been in the location as originally shown, as it is on a hill, and there is no evidence of there ever being a spring in that location. In my opinion the drawing is deficient. The drawing doesn't give a tie to the P.O.D.

I have mapped the place of use of this certificate for the purpose of clearity, as well as the transfer of place of use. The point of diversion is intended to remain at the springs, and Mr. Martin uses the Unnamed stream as well as the channel of the Powder River as part of his distribution system. He uses a pump the pick up the water again and sprinkle it over his land.
