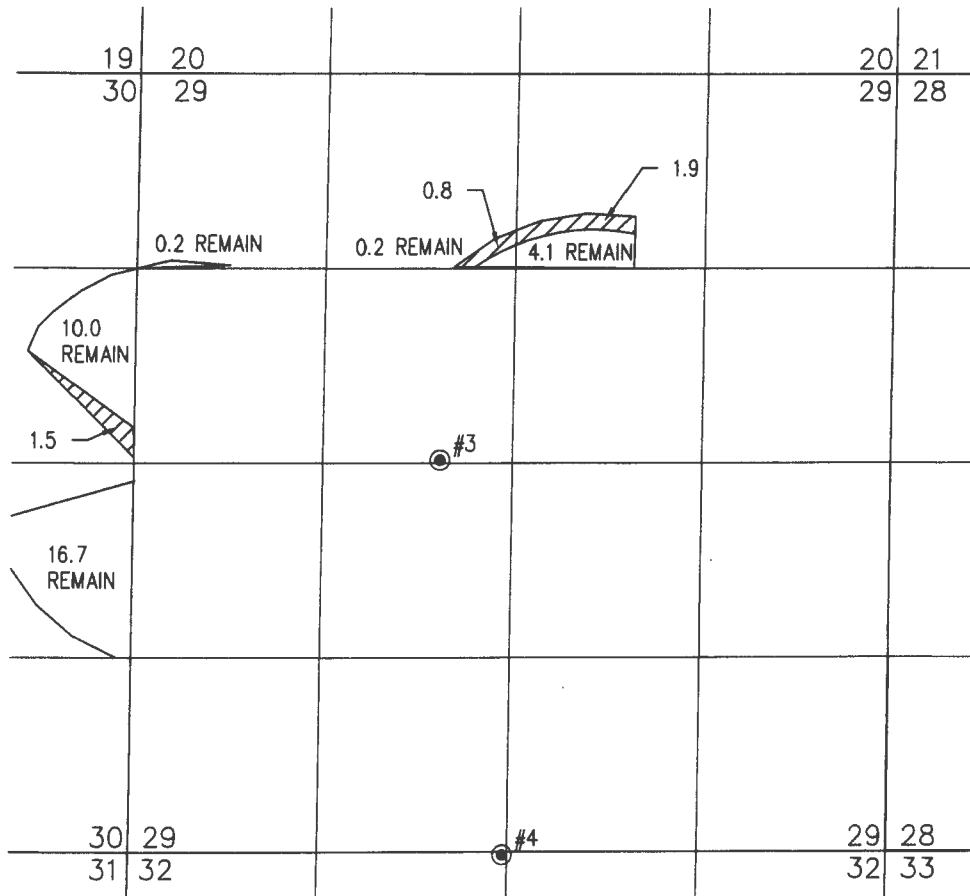

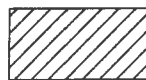
"FROM" TAX LOT 2800 IN

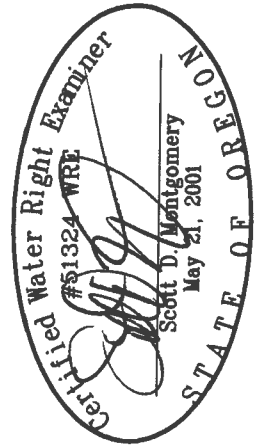

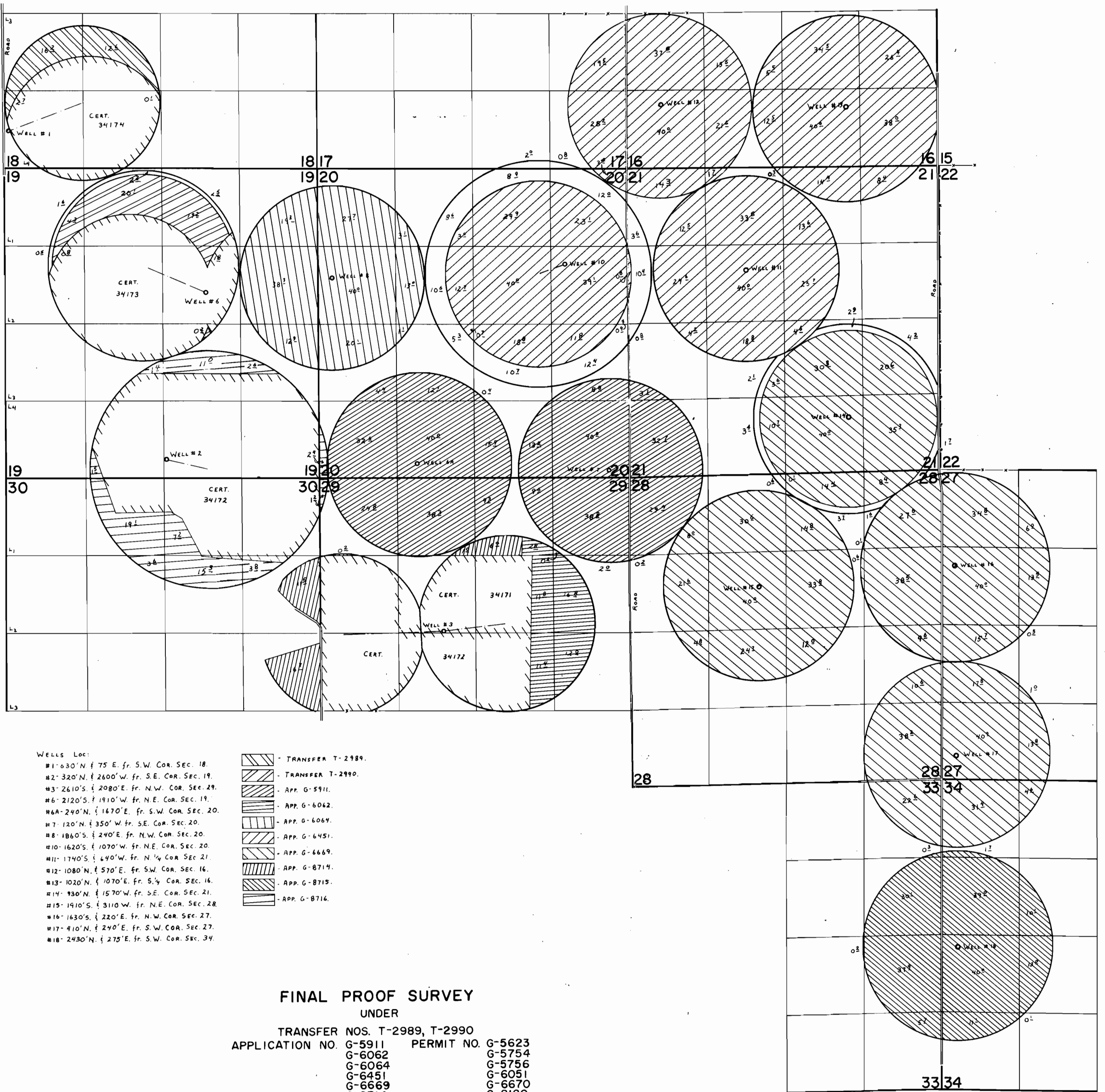
