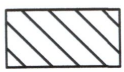

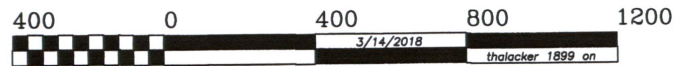
Portion of Tax Lot 1401
