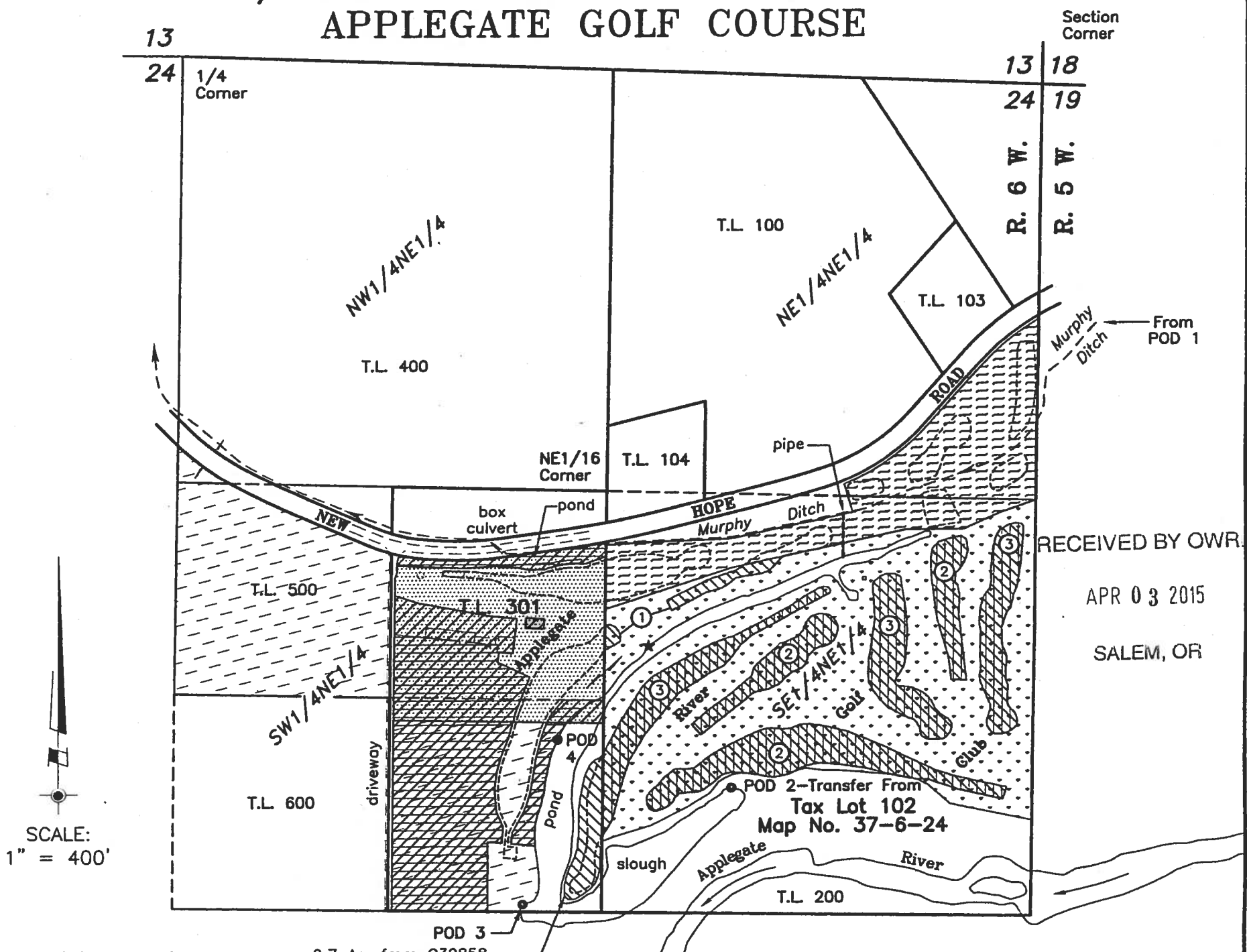

The purpose of this application is to transfer 8.6 acres of 1902 water rights to the tees, greens, and fairways of the golf course, to transfer 7.6 acres of 1980 rights onto a portion of the vacated 1902 sites, to transfer POD 2 to POD 3 and POD 4, and to apply for additional points of diversion at POD 3 and POD 4. All 43.2 acres of rights will receive water from both POD 3 and POD 4.

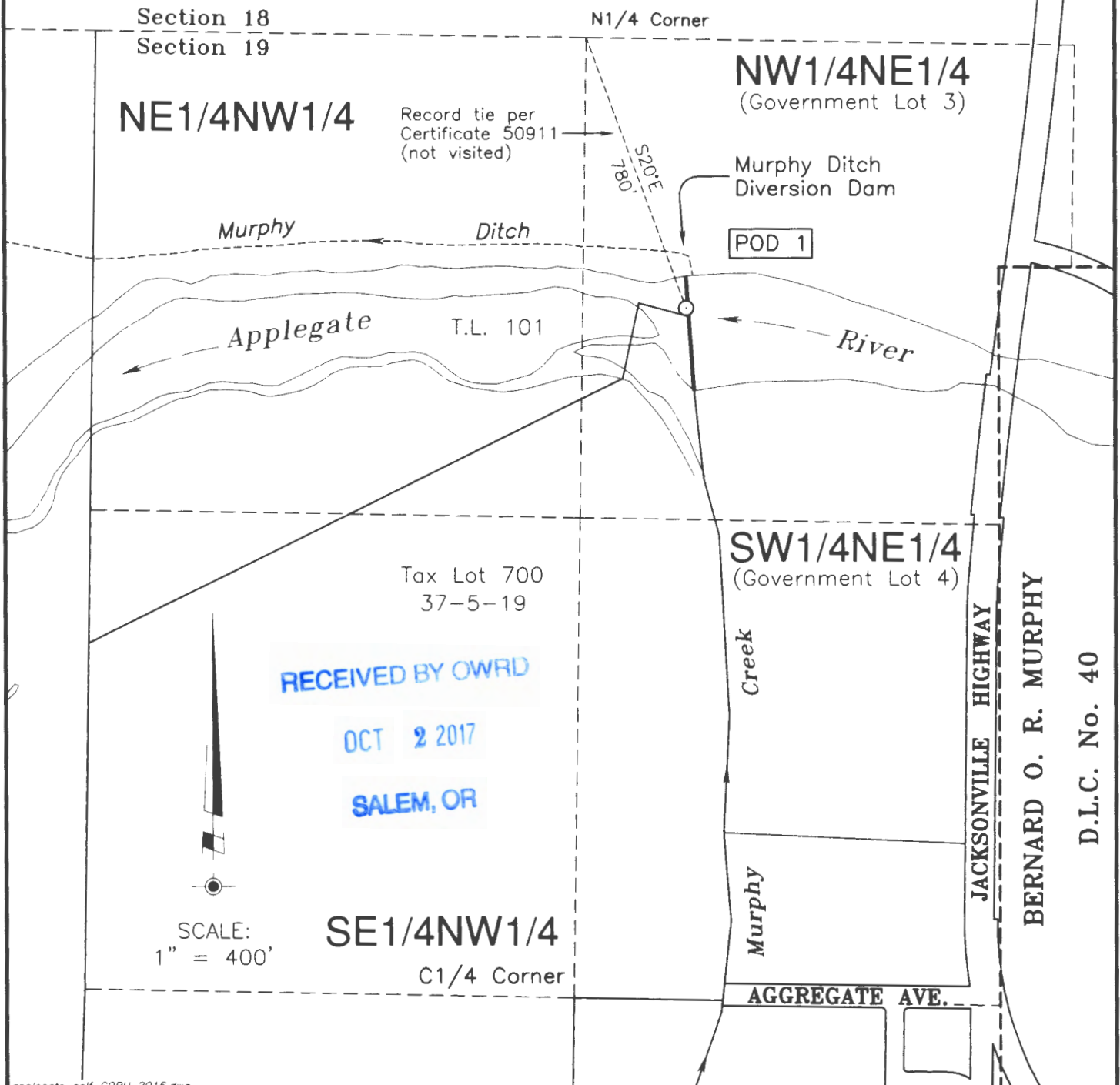

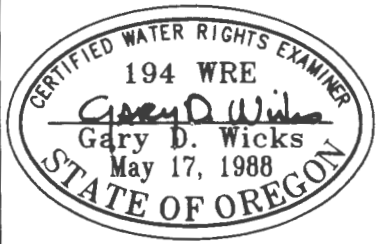
