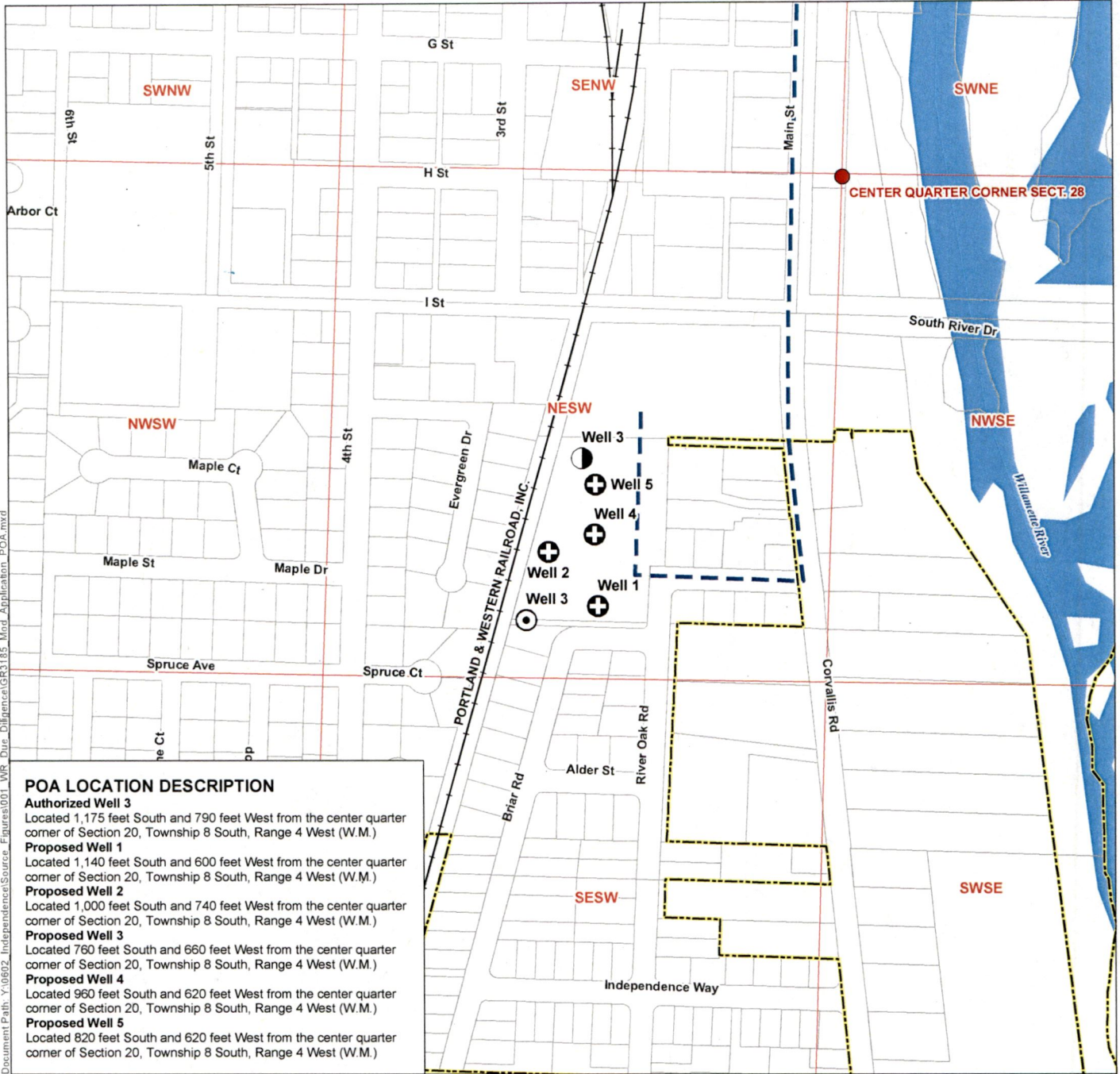

Authorized Well 3

Located 1,175 feet South and 790 feet West from the center quarter corner of Section 20, Township 8 South, Range 4 West (W.M.)

Proposed Well 1

Located 1,140 feet South and 600 feet West from the center quarter corner of Section 20, Township 8 South, Range 4 West (W.M.)

Proposed Well 2

Located 1,000 feet South and 740 feet West from the center quarter corner of Section 20, Township 8 South, Range 4 West (W.M.)

Proposed Well 3

Located 760 feet South and 660 feet West from the center quarter corner of Section 20, Township 8 South, Range 4 West (W.M.)

Proposed Well 4

Located 960 feet South and 620 feet West from the center quarter corner of Section 20, Township 8 South, Range 4 West (W.M.)

Proposed Well 5

Located 820 feet South and 620 feet West from the center quarter corner of Section 20, Township 8 South, Range 4 West (W.M.)

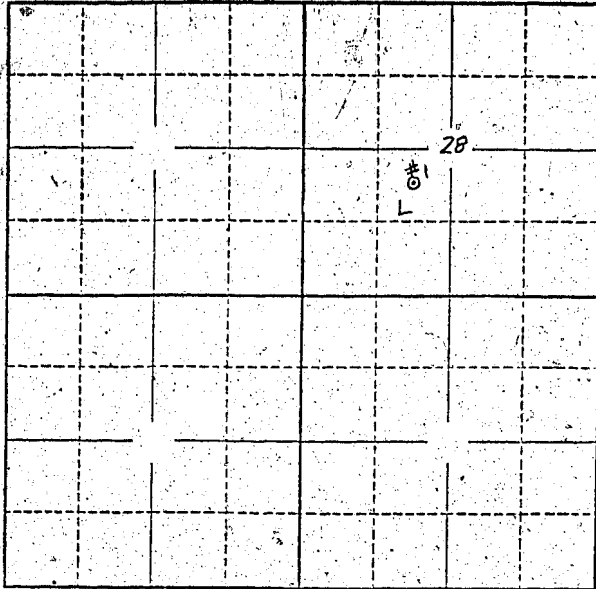
