Louden and Jessie Louden and Ora Smith, Said Leonard appearing by L. R. Webster, her attorney, and the other objectors and movers appearing by H. D. Norton, their attorney, and the Court having sat and heard the arguments of respective counsel, and now being fully advised in the premises,

IT IS ORDERED that the objections of Mary Ellen Leonard No. 1 to Finding No. 10 and objection No. 17 to Paragraph No. 1 of order of determination be and hereby are sustained in so far as the name N. E. Leonard in said Findings and Order relate to claimant Mary Ellen Leonard. That all objections other than those last stated, made by said Mary Ellen Leonard herein be and hereby are overruled.

That the motion of John C. Louden and Jessie Louden be and hereby is granted.

That the objection of J. E. Lewis and Charles R. Williams be and hereby are sustained to the extent that the dating of the ditch be 1872.

That the objection of J. D. Wimer be and hereby is denied.

That the objection of J. E. Lewis is sustained and that the dating of his ditch be 1872.

That the motion of Ora Smith is granted.

Except as hereinbefore set forth, the Findings and Order of Determination of the Board of Control herein are in all things confirmed, and adopted as the Findings and decree of this Court.
