DECREE

Heretofore the Board of Control of the State of Oregon for Water Division Number One for said County, filed in this Court its findings of Fact and Order of Determination, and now at this time this matter comes on on motion of Gus Newbury, attorney for George W. Dunn, for the entry of Decree in the said matter, based upon the said Findings of Fact and Order of Determination heretofore filed herein.

And it appearing to the Court that all of the parties to these proceedings appeared before said State Board of Water Control either in person or by their respective attorneys or both;

And it appearing to the Court that a decree of this Court should be made, based upon the said Findings of Fact and Order of Determination as filed herein by the said Board of Control;

NOW THEREFORE, based upon said Findings of Fact and Order of Determination, it is ordered, adjudged and decreed by the Court that the said Findings of Fact and Order of Determination of the Board of Control of the State of Oregon be and hereby are adopted as the Findings of Fact and Conclusions of Law and Order of Determination of this Court in the matter of the Determination of said Water rights;

And it is further ordered, adjudged and decreed by the Court that the names of the claimants, the date of relative priority and the amount of cubic feet of water per second and the amount of acres irrigated, the use and irrigation and mining seasons respectively, the names of the ditches through which the waters are used and the description of the lands or places used, as found by the said State Board of Control in their said Findings of Fact and Order of Determination be and the same hereby are decreed to be the name of the claimants entitled to the use of water from said stream, the date of relative priority respectively and the amount of cubic feet per second of water and the number of acres irrigated, the character of use and irrigation and mining seasons respectively, the name of the ditch through which the waters are used and the description of the lands or places used, to which the claimants named in the Findings and Conclusions and Order of Determination are entitled and the purposes for which the said claimants shall be entitled in the use of the said water, to be the order and decree of this Court in those particulars;

And it is further ordered, adjudged and decreed by the Court that the said Findings of Fact and Order of Determination of the said State Board of Control be entered upon the Journal of this Court as the Findings and Conclusions of this Court and as explanatory and determinative of the Findings, Conclusions and Decree of this Court, and as a part of this Decree it appearing that the attorneys for the several claimants herein have been duly served with notice and Motion for the entry of this Decree.
