FINDINGS OF FACT AND  
ORDER OF DETERMINATION.

Now on this 23rd day of May, 1921, the above entitled matter coming on for hearing and for the making of Findings of Fact and an Order of Determination by said Board on motion of Geo. T. Cochran, State Water Superintendent, and the Board having considered the testimony and evidence herein, and all the statements and proofs of claim of the various claimants on file herein, and being now fully advised in the premises, now makes the following as its

FINDINGS OF FACT AND ORDER OF DETERMINATION.

1.

That Fifteen Mile Creek is a natural non-navigable water channel rising in the eastern slopes of the Cascade Mountains and flowing in a northerly and easterly direction into the Columbia River, and with the possible exception of a small portion of the drainage basin at the extreme headwaters thereof, lies wholly within the County of Wasco, State of Oregon.

2.

That during the growing season the rainfall is insufficient to furnish moisture for the profitable growing of certain agricultural crops; that the lands in said vicinity are semi-arid in character, and that irrigation is and at all times has been beneficial and necessary to produce the best growth of said crops.

3.

That on the 11th day of August in the year 1914, a petition was filed with the State Water Board requesting a determination of the relative rights of the various claimants to the waters of said stream and its tributaries; that said petition was signed by R. Brookhouse, C. E. Haight, F. L. Petersen, P. E. Lamar, Joseph Boyer, James Fulton and S. P. Ward.

4.

That thereafter and upon investigation,,the State Water Board found the facts and conditions such as would justify making a determination of the relative rights of all the claimants to the right to use water from said stream and its tributaries, and an order was entered by said Board fixing the time when the State Engineer would make the examination of the stream, and the time when the State Water Superintendent would begin taking testimony.

5.

That said Board prepared a notice setting forth the date when the State Engineer of Oregon would begin an investigation of the flow of the said stream and of the ditches diverting water therefrom, the place and time certain when the State Water Superintendent would begin the taking of testimony as to the rights of the parties claiming water therefrom, and thereafter said notice was published, according to law, in two issues of The Dalles Chronicle, a newspaper published and of general circulation in said Wasco County, Oregon, the date of the last publication being more than 30 days prior to the beginning of the taking of testimony by said Superintendent as fixed in said notice, or the time fixed in said notice for the examination of said stream by said State Engineer or his assistant; proof of publication of said notice being a part of the record herein.

6

That more than 30 days prior to the date fixed in said notice for taking testimony or said examination by said State Engineer, the State Water Superintendent did send by registered mail to each person, firm or corporation claiming a right to the use of any of the waters of said stream, or being in possession of lands bordering on or having access to said stream or its tributaries, in so far as such claimants and owners and persons in possession could be reasonably ascertained, a notice being similar to the notice published as heretofore mentioned, setting forth the date when the State Engineer or his assistant would begin the examination of said stream and the ditches diverting water therefrom, and also the date when the Superintendent would take testimony relative to the rights of the various claimants to the waters of said stream; due proof of the mailing of the said notice being now on file and a part of the record herein. That said Superintendent did enclose, together with said notice, a blank form on which said claimant so notified might set forth in writing all the particulars necessary for the determination of his rights to the waters of the said stream, and which would show a compliance with the law in acquiring such rights.

7.

That upon the date named in said notice a duly qualified assistant to the State Engineer of Oregon did proceed to make an examination of said stream and the works diverting water therefrom, including the measurement of said stream and the carrying capacity of the various ditches and canals; and examination of the irrigated lands, and an approximate measurement of the lands irrigated or susceptible of irrigation from the various ditches and canals; which said observations and measurements have been reduced to writing and made a matter of record in the office of said State Engineer, together with maps or plats showing with substantial accuracy the course of said stream, location of each ditch or canal diverting water therefrom, and the legal subdivisions of land which have been irrigated or which are susceptible of irrigation from said ditches and canals already constructed; copies of said observations, measurements, maps and data duly certified to being on file and a part of the record herein.

8.

That upon the date named in the aforesaid notice the State Water Superintendent of Oregon (as more fully appears from his certificate on file and now a part of the record herein) began taking testimony in the above entitled matter and continued the same to completion, and the following named persons appeared and submitted proof of their right to the use of the waters of the above named stream, to-wit:

That each of the above named claimants did set forth the particulars necessary for the determination of their rights to the use of the waters of said stream in writing, under oath, together with such other facts as tend to show a compliance with the law in applying said rights, and said proofs are now a part of the record herein, and that there was no other testimony offered on behalf of said claimants or any of them.

9.

That the following named persons, firms or corporations were duly notified by registered mail and by publication of said notices, as hereinbefore set forth, and that each and all of them although so notified have failed, neglected and refused to appear herein and to submit proof of their rights to the use of the waters of said stream, if any they have or claim, and such parties are in default and that such default is entered against them, and that each of them is hereby enjoined and inhibited from using or asserting any rights to the use of the waters of said stream except by, through, or under rights hereinafter acquired in accordance with law, to-wit:

That upon the completion of the taking of said testimony aforesaid, the State Water Superintendent of Oregon gave notice by registered mail to the above named claimants that at the time and place named in said notice, all the said evidence taken as aforesaid would be open to the inspection of said claimants and all other persons interested, said period of inspection being more than ten days after the giving of said notice by registered mail as aforesaid; and thereupon said Superintendent did open said evidence to inspection at said places and as fixed in said notice, and kept the same open to inspection for a period of ten days (excluding Sundays); and it was set forth and stated in said notice that the determination of said Board in the above entitled matter would be heard by the Circuit Court of the State of Oregon for Wasco County, in which county said stream is situated. That due proof of the mailing of said notice and the holding of said inspection is now on file and a part of the record herein.

## 11.

That no contests were filed within five days after the period of inspection as aforesaid, or at all. That thereafter all the evidence taken in this proceeding was duly transmitted by said Superintendent in person to said State Water Board and filed in the office of said Board at Salem, Oregon.

## 12.

That the following named claimants are the holders of permits issued by the State Engineer of Oregon, and the rights initiated by the applications for each of said permits shall be completed and perfected in accordance with the terms and conditions set forth in said permits and the laws of the State of Oregon, and where final proof of the completion of the irrigation works and the complete application of water to beneficial use has heretofore been made to the satisfaction of the State Water Board, such certificates are hereby validated the same as if they had been issued under and by authority of this Order of Determination. That the name of claimants holding such permits together with the permit number, the date of priority, and the stream from which the appropriation is to be made is as follows, to-wit:

That the following named claimants have failed to use the water heretofore appropriated for a period of five successive years, and in accordance with the terms of Section 5776, Oregon Laws, such failure to use is conclusive proof of the abandonment of such water rights to-wit:

14.

That from the records of the flow of Fifteen Mile Creek and its tributaries on file herein, it appears that the water supply is more than sufficient to properly irrigate the lands now irrigated from said streams during the early part of the irrigation season, but that said water supply is variable and insufficient to supply all the needs throughout the irrigation season; that said partial failure occurs early in the season and the deficiency increases as the season progresses, until during a part of June in some years and during the months of July, August and September the water supply is only sufficient to properly irrigate a small portion of the area for which water rights are claimed herein. That the character of the soil being irrigated is variable but in general consists of a light sandy loam of variable depth, of volcanic origin, and that the soil is readily susceptible to irrigation.

15.

That a proper head of water is necessary for the most successful and economical irrigation of land, and that three acre feet of water per acre measured

at a point of diversion is a sufficient quantity to apply on the lands involved herein for the proper irrigation thereof during any one season; that a continuous flow of one-eightieth of a second foot per acre will supply such quantity in approximately one hundred and twenty days; but that a head of water of one-eightieth of a second foot per acre is inadequate for the proper irrigation of land; that in order to irrigate any land it is not necessary to keep a continuous flow of water upon each and every acre of the same, and that the intermittent use of water on such land makes it possible to use a set system of rotation, so that the head of water necessary for the irrigation thereof is obtained.

That in order to meet the foregoing conditions the right to the use of water from Fifteen Mile Creek and its tributaries, except as otherwise provided herein, shall be limited to the diversion of not to exceed one acre foot per acre during any 30 day period up to July 1st of each year and thereafter not to exceed three-fourths ( $3/4$ ) acre foot per acre during any 30 day period, provided that the total quantity of water diverted during the irrigation season shall not exceed three acre feet per acre, and provided further that the rate of flow shall not exceed one-fortieth of a second foot per acre after July 1st, except in case of rotation.

16.

That all claimants herein for water for irrigation shall be entitled to use such water for stock and domestic purposes, and that the right of use for stock and domestic purposes is hereby confirmed and entitles the owner of such right to divert and use such a quantity of water as is reasonably necessary for his domestic and household use and for stock purposes, provided the amount so diverted and used shall not exceed the rate of one-fortieth of one cubic foot per second for each one thousand head of stock, and the quantity of water diverted for irrigation purposes during the irrigation season shall include such an amount as may be reasonably necessary for said stock and domestic purposes, but the right to divert and use water for stock and domestic purposes shall continue throughout the year.

17.

That the rights to the use of water for irrigation purposes hereby confirmed are appurtenant to the lands herein described, and the rights of use of the waters of said stream and its tributaries by virtue of such rights, are limited and confined to the irrigation of the lands herein described to the extent of said lands herein set forth, and the priorities of right herein confirmed, confer no right of use of the waters of said stream and its tributaries on any lands other than those specified tracts to which such rights are herein set forth as appurtenant, and each

and every person shall be, and hereby is, prohibited, restrained and enjoined from diverting and using water from said stream on such other lands without lawful permit first obtained from the State Engineer.

18

That the order of the rights of the respective appropriators of waters of said stream and its tributaries, and in which order they are entitled to divert and use the said waters shall be and is according to the date of the relative priority of the rights as herein set forth and determined, and the first in order of time according to the date of relative priority shall be and is the first in order of right and so on down to the date of the latest right, and those having prior rights are entitled to divert and use the waters of said stream and its tributaries when necessary for beneficial use in connection with the irrigation of their respective lands or other useful and beneficial purposes for which they are decreed the right of use at all times against those having subsequent rights without let or hinderance, and whenever the water is not required by the appropriator having a prior right to its use for the purpose for which said water was appropriated, he must and shall permit it to flow down the natural channel of the stream as it was wont to flow in its natural course without hinderance or diversion thereof, and those having subsequent rights are entitled to the use of such water and to divert the same to the extent of their rights of appropriation according to the order of priority of their rights; and at all times the waters shall be beneficially, economically, and reasonably uses without waste by those having a right to the use of such water, and no rights of appropriation are hereby confirmed to divert a greater quantity of water into the head of the ditch or ditches of the appropriator having valid right to divert water than such appropriator can beneficially use for the purpose to which the water is to be put.

19.

The Water Master of the district in which Fifteen Mile Creek and its tributaries is situated, shall arrange such system or systems of rotation as may be best applicable, either by giving a greater amount of water for a proportionately less time, or by arranging such appropriators in groups or systems of rotation, first giving the appropriator who is first in priority, an amount of water equal to the combined appropriations of all the appropriators in said group or system for a length of time bearing the same ratio to the whole time required to make complete rotation through the whole group or system, as the appropriation of the said first appropriator bears to the combined appropriations of said appropriators, and shall serve the next



appropriator in priority next, with a like amount of water for his proportionate time, and so on until all the appropriators in said group are served. Then the distribution of water shall be repeated in the same manner throughout the irrigating season. In case any two or more appropriators in said group shall have the same priority, then the said Water Master shall distribute the water as between those having the same priority to the one whose ditch taps the stream next its source first, and the next lower down next, and so on, and when two or more appropriators agree among themselves as to a manner and system of rotation in the use of their water, the said Water Master shall distribute their water in accordance with such agreement. That in case the water flowing in the channel of Fifteen Mile Creek sinks or fails to flow down the channel thereof so as to be of beneficial use to the appropriator having the prior right to its use, the Water Master shall allow the diversion thereof by the next in order of priority who can make a beneficial use of such water. Provided, however, that nothing contained in these findings shall operate to interfere with the prior rights of any appropriator not a member of any of such groups or systems of rotation.

20.

That the name and address of each appropriator of water from said Fifteen Mile Creek and its tributaries arranged in a tabulated form, together with the date of relative priority of such appropriation, the number of acres to which such appropriation is applied, the use or uses for which said water was applied and is now limited, the name of the ditch or ditches through which the water so appropriated is diverted, the name of the stream or streams from which the water so appropriated is diverted, and the description of the land upon which such water is used; the tabulated rights of each appropriator, being set opposite and following the name and post office address of each appropriator, is as follows, to-wit:
