IN THE MATTER OF THE DETERMINATION OF THE RELATIVE RIGHTS TO THE USE OF THE WATERS OF OWYHEE RIVER AND ITS TRIBUTARIES, A TRIBUTARY OF SNAKE RIVER.

DECREE MODIFYING ORDER OF DETERMINATION OF STATE ENGINEER.

decree upon the findings and order of determination of the State Engineer filed herein, and upon the objections and exceptions heretofore filed by various claiments to
waters from said streams to the order of determination so filed by the said State
Engineer; and the matter having heretofore been argued to the Court by counsel representing the various claimants, and said cause having been referred to the court reporter to take further testimony on certain objections, and said testimony having been
transcribed and filed herein, and the Court having this day filed its order and decree
amending in certain respects the order of determination of the State Engineer entered
in said matter, and it appearing that a final decree should be entered completely desoribing the rights of the parties hereto, and the Court being at this time fully advised in the premises, It is hereby CONSIDERED, ORDERED, and DECREED, that all things done
and had by the said State Engineer in the premises as found and determined, are hereby
adopted and approved and made the findings and order of determination of this Court.

1.

the Board of Control of the State of Oregon (afterwards State Water Board, and now State Engineer) a petition signed by Warren J. Kellogg and others, requesting the determination of the relative rights of the various claimants to the waters of Jordan Creek, and its tributaries, a tributary of Owyhee River; that on the 21st day of September, 1914, there was filed in the office of the State Water Board, a petition signed by R. L. Munger and others, requesting a determination of the relative rights of the various claimants to the waters of Jordan Creek and its tributaries; that on the 20th day of February, 1917, there was filed in the office of the State Water Board, a petition signed by Dennis Driscoll and others, requesting a determination of the relative rights of the various claimants to the waters of Cow Creek and its tributaries, a tributary of Jordan Creek, tributary of Owyhee River; that on the 15th day of March, 1917, there was filed in the office of the State Water Board, a petition signed by Dennis Driscoll and others, requesting a determination of the relative rights of the various claimants to the waters of Cow Creek,

and its tributaries; that on the 31st day of December, 1919, there was filed in the office of the State Water Board, a petition signed by Anna D. S. Pratt and others, requesting a determination of the relative rights of the various claimants to the waters of Owyhee River, and its tributaries; all of the said petitioners being water users on the stream named in their respective petitions. That thereafter the State Water Board, after a full investigation and due consideration of said petitions, finding the facts and conditions such as to justify it, made and entered an order that a determination be had of the relative rights of the various claimants to the waters of Jordan Creek, and its tributaries, fixing a time for the making of the necessary surveys and examinations, and the beginning and taking of such testimony as would enable the Board to determine the rights of the various claimants to the use of water from said stream, as provided by law.

2.

the State Engineer did proceed to make investigations of the flow of Jordan Creek, and the ditches and canals diverting water therefrom, and of the lands irrigated from such ditches and canals. That prior to the completion of such surveys and investigations, and on the 12th day of January, 1920, there was filed in the office of said Board, an order of the Circuit Court of the State of Oregon for Malheur County, dated September 22, 1919, in the case of the Owyhee Ditch Company, a corporation, plaintiff, vs. Fred Klingback and others, defendants, directing that said cause be referred to the State Water Board for the purpose of adjudicating the relative rights of all the water users from Owyhee River, and its tributaries. That thereupon the State Water Board entered an order directing that such determination be made, and that the State Engineer proceed to make the necessary surveys and examinations in addition to those already made on Jordan Creek and its tributaries, and that the State Water Superintendent proceed to take such evidence and testimony as would enable the Board to determine the relative rights of the various claimants to the waters of Owyhee River and its tributaries.

3.

That a notice was prepared by said Board setting forth the date when the State Engineer or his assistants would begin the investigations of the flow of said Owyhee River and its tributaries, and the ditches diverting water therefrom, and a time and place certain when the State Water Superintendent would begin the taking of testimony as to the relative rights of the various claimants to the use of the waters thereof, and said notice was published in two issues of the Malheur Enterprise, a newspaper published weekly, at Vale, Oregon; said two issues being those of July 18th and 25th, 1921, and said notice was published in two issues of the Ontario Argus,

a newspaper published weekly at Ontario, Oregon, said two issues being those of June 16th and 23rd, 1921; and said notice was published in two issues of the Jordan Valley Express, a newspaper published weekly at Jordan Valley, Oregon, said two issues being those of June 17th, and June 24th, 1921; all of said newspapers being of general circulation in the said County of Malheur, State of Oregon, and the date of the last publication of said notice in each instance, being more than 30 days prior to the date fixed for the beginning of the measurements of the stream by the State Engineer, and the beginning of the taking of testimony by the State Water Superintendent.

4.

That the time when the said State Engineer or his assistant should begin the examination of said stream, and its tributaries, was set for Monday the first day of August, 1921, and the times and places when and where the State Water Superintendent or his duly authorized assistant should attend and take the testimony of the various claimants, were set as follows:

On Tuesday, the 2d day of August, 1921, in the Circuit Court Room of the County Court House at Vale, Oregon;

On Wednesday, the 3d day of August, 1921, in the City Hall at Ontario, Oregon:

On Friday, the 5th day of August, 1921, in the Hall of the Jordan Valley Hotel at Jordan Valley, Oregon;

And for a period of 30 days beginning on Monday the 15th day of August, 1921, at the office of the State Water Superintendent, at La Grande, Oregon.

Б.

That on the 15th day of June, 1921, the State Water Superintendent did send by registered mail, to each person, firm or corporation claiming a right to the waters of said stream, or any tributary thereof, and to each person, firm or corporation owning or being in possession of land bordering on or having access to said stream or its tributaries, insofar as said claimants, owners, firms or corporations could be reasonably ascertained, a notice similar to such published notice, setting forth the date when the State Engineer or his assistant would commence the examination of the stream, and the time and place when the State Water Superintendent would commence the taking of testimony as to the relative rights of the various claimants to the waters of said stream or its tributaries. And said Superintendent did enclose with each of said notices, a blank form upon which said claimant or person in possession could present in writing all the particulars necessary for the determination of his rights to the waters of said stream, or a tributary thereof, under oath.

That due proof of publication of said notice, and of the sending of said notice by registered mail, has been made and is duly filed as a part of the record hereof.

That at the time specified in said notice, a duly qualified assistant of the State Engineer did proceed to make an examination of said stream and its tributaries, and of the ditches and canals diverting water therefrom, and of the land irrigated from said ditches or canals, which observations and measurements were reduced to writing, and made a matter of record in his office. And the State Engineer did cause to be prepared a set of maps or plats, on a scale of measurement of four inches to the mile, showing with substantial accuracy the course of said stream and its tributaries, the location of the various ditches diverting water therefrom, and the number of seres of land which had been irrigated in each legal subdivision; blue prints of said maps and plats being now on file and a part of the record herein.

7.

That during the period specified in said notice for the taking of testimony, the State Water Superintendent did attend and take the testimony of the various claimants. That statements and proofs of claim to the use of the waters of said stream or its tributaries were filed by the following parties, to-wit:

That after the filing of said statements of contest, the State Water Superintendent did fix a time and place for the hearing of each and every of said contests
and did, on the 16th day of June, 1923, serve notice of hearing of said contests on each
of the parties to each and every of said contests, the dates fixed for hearing each instance being more than 30 days and less than 60 days from the date the notice of hearing
was served upon said parties. That due proof of serving of said notices has been made
and filed as a part of the record herein.

That the time so set by said notices was later extended to suit the convenience of the interested parties. That upon the dates as finally fixed for the hear-

ing of each of the respective contests, the taking of testimony upon said contests was commenced before a duly authorized reporter, and continued until each and every of said contests were fully heard, settled, or otherwise disposed of.

W. F. Stine, Wm. Wiedeman and Carleton Fretwell.

J. B. McCain, (Successor in interest to Frank P. Rose), J. E. McDonnell, and W. S. Skinner,

Contestees.

The water rights through the Happy Valley Ditch were initiated by W. F. Stine, Carleton Fretwell, and G. C. Fretwell in November, 1908, by posting a notice of appropriation, and it was contemplated to furnish water through this ditch to irrigate the lands under said ditch now owned by the contestees, and other lands then owned by the appropriators. They proceeded with the construction of the ditch and completed the same in the year 1910, and found it was not feasible to irrigate the lands now owned by the contestants through said ditch, and during the year 1913 sold the lands now owned by contestees, together with said ditch and water appropriations. At the time of sale very little land had been brought into a state of cultivation and waters applied thereto, and at the time of taking testimony in this case the contestees had brought into a state of cultivation about 173 acres of the lands under their ditch. and claim is made for an incheate right for the irrigation of the remainder of their lands susceptible of irrigation under said ditch. It is ordered that the contestees and their successors in interest have two years from date of this decree to complete their application to beneficial use upon the land. At the expiration of said time the State Engineer shall make a survey of the land reclaimed in each legal subdivision and include all of the irrigated land in his Certificates of Water Right issued to the respective parties.

It is further found that W. S. Skinner owns eight-twentieths of said ditch, J. E. McDonnell owns five-twentieths, and J. B. McCain, seven-twentieths.

It is further found that Contestant Carleton Fretwell has filed exceptions, number 3438, to said findings and order of determination, claiming that said order should also specify and determine the right to sufficient water current of the Owyhee River to operate a current wheel, in addition to the amount of water allowed to irrigate his lands. Since the argument of this case additional testimony has been taken on the question as to the quantity of water required in the stream to operate said water wheels and it appears that at times there is not sufficient water in the stream to operate the same. And the Court is of the opinion that our Water Code does not provide for such an appropriation of the waters of the State. It is ordered that the application of Contestant be and the same is BWYHEE RIVER -9-9/ hereby denied.

John Acarregui

That this claimant has 70.6 acres which are entitled to a right under the Goodrich or Hooker ditch, started in 1871. That beginning in 1872 the timber culture claim of Goodrich ($SW_4^2NW_4^2$ Section 10) and about 20 acres more, were irrigated from the Goodrich-King slough, and 84.7 acres have received benefit by overflow from the sloughs and dams placed in the channels of the stream since 1874.

Blackaby & Lees

That the first use of water on the lands of these claimants began in 1880, and under this appropriation 104.3 acres have been irrigated, under the Answelt and Sharpe Ditch, on the south side of Jordan Creek in Section 1, Township 30 South, Range 45 East, W.M. In 1880 the ditch was enlarged and extended to cover 143 acres of Section 36. Township 29 South, Range 45 East W.M.

That an area of 429.6 acres now owned by Iris G. Anawalt has also been irrigated under the Anawalt and Sharpe Ditch with priority of 1883.

That Blackaby and Lees and John Urlezaga stipulated with contestants that the priority of their water right for their land south of the channel of Jordan Creek in Sections 1 and 2, Township 30 South, Range 45 E. W. M., should be not earlier than 1880, and their rights are so tabulated.

J. B. Duncan

That this claimant has 25.6 acres of land and some lots in the Town of Jordan Valley which are entitled to a right through the Town Ditch, which was taken out in the spring of 1873. There is also an area of 69.4 acres which was reclaimed and irrigated by means of the Baxter & Parks ditch. This ditch was started in 1874, but was abandoned and work not resumed until 1886. That an area of 35.3 acres has also been reclaimed either by natural overflow or by dams placed in the sloughs, and that such reclamation was commenced about 1876.

R. E. & E. L. Dunn

That 90.2 acres of the lands of these claimants have been irrigated by

the waters of Trout Creek since 1871. A portion of such land, being in Lots 1 & 2 of Section 18, has been benefitted by the natural overflow from Jordan Creek, and is entitled to a supplemental right therefrom, with priority of 1871.

Jose Eiguren & Jose Zabala

That Jose Biguren and Jose Zabala have conceded the superiority of the water rights of Contestants, and in the distribution of water said Contestants shall therefore be entitled to the first right as against said parties. That as between the said Eiguren and Zabala and other water users, however, their respective rights shall be governed by the dates of priority as fixed in the tabulation hereinafter contained.

Eiguren & Navarro

That the land of these claimants is commonly called the Sheep Ranch, and beginning about 1866 it was used as a stage station and crops of wild hay resulting from the natural overflow of Jordan Creek were utilized. During these early years about 40 acres were thus irrigated, about 1880 an increase was made, by 1891 an additional 135 acres had been reclaimed, and after this date 90 acres additional have been irrigated.

Wm. Lembert

That this claimant has 334 acres of land which was reclaimed by means of the Hooker ditch, built in 1871, and 87.2 acres reclaimed under the Williams ditch, built in 1888. Water is also used from Hooker Creek to irrigate 71.7 acres additional, and to furnish a supplemental supply for the lands under the Hooker and Williams ditches. Jerome Long

That 20.7 acres of land belonging to Mr. Long, and also several lots in the Town of Jordan Valley, are irrigated through the Town ditch, under priority of 1873, and 120.6 acres have been reclaimed through the Parks-weir-irrigation-slough ditch, under priority of 1875.

Eulogio Madariaga

That this claimant has 56 acres under the Town Ditch, in addition to some lots in the Town of Jordan Valley, and has stipulated that his priority shall be 1895 and his rights inferior to those of Contestants. An incheate right was also claimed for an additional 28.6 acres of raw land under the Town Ditch, which is denied because of the great lapse of time since the initiation of the right.

W.S. Maher

That 107.4 acres have been irrigated under the Town Ditch, and 286.8 acres irrigated mostly on the south side of Jordan Creek beginning with 1874, by various dams and ditches; and 121.4 acres irrigated under the Maher ditch built in 1902.

R. L. Munger

That an area of 45 acres of this ranch is entitled to a water right with priority of 1869, by virtue of settlement on and use of naturally overflowed lands.

In addition, 74.7 acres were irrigated under the Munger-Cowgill Fretwell ditch, with priority of 1887, 24 acres under the Lambert-West or Williams ditch which was built in 1888, and 33 acres under the Lambert-East or Hooker ditch which was built in 1871.

In addition to the lands of this claimant under the Munger-Cowgill-Fretwell ditch, considerable land now owned by Cowgill, Fretwell and others has been irrigated under this ditch, with priority of 1887.

Fred J. Palmer

Palmer, being a part of what is known as the "Ruby Ranch", and that wild meadow hay was cut on the meadows along the creek bottoms where the waters of Jordan Creek naturally overflowed. That an area of about 150 acres was irrigated in this manner, and about 25 or 30 acres artificially irrigated, making about 175 acres that is entitled to a water right dating from the first use, or 1869. In the year 1888 construction was started on artificial works for the irrigation of additional land, and within a reasonable time about 247.2 acres were irrigated thereby. That the land in Section 15 was cleared up and irrigated after 1902, and is not entitled to a water right earlier than that date. Up to the commencement of this adjudication some 486.6 acres had been reclaimed in this section. On account of the delay in applying the water to beneficial use the right for any lands irrigated since the commencement of this proceeding cannot relate back for priority to the dates of the above appropriations, but should be covered by a permit obtained from the State Engineer.

Julia A. Parks

That Mrs. Parks has 37.2 acres and some lots in the town of Jordan Valley under the Town ditch, taken out in 1873, and 60 acres irrigated through the Parks-Weir - irrigation-slough ditch, the water right for such land having been initiated in 1875. In addition there is 65 acres under the Baxter and Parks ditch, which was first started in 1874, but on which work was abandoned and not resumed until 1886.

W. S. Skinner

owned by W. S. Skinner, commonly called the Goose Ranch, and crops of wild meadow hay were cut from the lands which were naturally overflowed along the channel of Jordan Creek. During the next 15 years about 65 acres of land were irrigated on the ranch, including some 25 or 30 acres which were irrigated by a dam and ditch built in 1875. Beginning about 1887, and after additional land was taken up, the irrigated area was increased, and by about 1899 there was a total of about 485 acres which had been reclaimed. All the balance of the land which has been put under irrigation up to the beginning of this proceeding, comprising about 925 acres, was reclaimed after the year 1901. There has been some additional land put under irrigation since this proceeding was commenced,

and an inchoate right was claimed for a still larger acreage to be reclaimed in the future. The water right for such land, however, must be initiated by a filing made with the State Engineer, and cannot relate back for priority to the appropriations started more than 20 years ago.

John S. Swisher

That the predecessors of this claimant commenced the use of water for raising wild hay crops in 1871, and there are 117.8 acres entitled to a water right as of that date. The water right for the balance of the land, including the Canter desert claim, was initiated in the year 1882, and 192.6 acres have been reclaimed under this appropriation.

The Town Ditch

That the Town Ditch was started in the spring of 1873, and the lands now irrigated under it were reclaimed within a reasonable time thereafter. Most of the lands under this ditch are mentioned in the findings as to individual rights, but there are also some town lot owners in Jordan Valley who secure water through this ditch. It was stipulated that such rights should take the priority which said ditch might be awarded. The Town Ditch also takes water from Trout Creek, although its head is located on Jordan Creek above the mouth of Trout Creek. The Town Ditch was started in construction in the spring of 1873, and it is hereby decreed a date of priority of 1873.

Contestants

That contestants have filed their amended proof of claim herein, which is allowed, and that as to their rights it is found that the water right of contestants was initiated by David R. King in the year 1872, wherein it is shown that he raised and harvested a crop of wild hay on a portion of contestants' premises, followed in 1873 by the construction of the ditch system for the irrigation of all the lands (above the overflowed lands), to which lands he subsequently acquired title, the same being: SEANWA, NASWA, and SWASWA Section 10, and the SEA Section 9, all in Township 30. South, Range 46 E. W. M. In Addition to the diversion of waters from Jordan Creek, they claim a right to the use of the spring waters of that certain spring heretofore developed in what is known as the King-Goodrich Slough, which is situated about one mile above the point where the King Ditch taps said slough. In 1880 appropriation was made to cover the SW2 of Section 9, Township 30 South, Range 46 East; that in the year 1894 the appropriation was increased to cover the SE2 of Section 8, T. 30 S. R. 46 E. W. M. It is ordered that the foregoing lands shall have a water right from Jordan Creek, its tributaries, and said springs, with priority as of said respective dates, namely, 1872, 1880 and 1894, and it is ordered that the said dates appearing in the tabulation of the State Engineer be changed to conform to the dates above mentioned.

extent of the right claimed by Contestee, Hollister A. Parks, to the waters of a certain spring. That Contestee has furnished sufficient proof to establish his claim, and his rights will therefore be allowed as set forth in his statement and proof of claim. It appears that Contestee also has certain rights to the use of the waters of Cow Creek under a final certificate issued under Permit 188 of the State Engineer, with priority of November 3, 1909. At the beginning of the hearing in this contest, Contestee attempted to amend his claim to include a right with priority of May 20, 1907 for water from Cow Creek as well as from the spring. This claim is not supported by the testimony, and is denied.

Exceptors and Objectors.

It is ordered that the exceptions and objections filed herein by E. M. Blodgett et al, be, and the whole thereof, are hereby denied, save and except as the same may be allowed under other exceptions. That since the hearing of the above contest the exceptors, K. S. D. Fruit Land Company and Julia Kiesel, Fred W. Kiesel and Wilhelmina Pauline Shearman, a co-partnership doing business as Fred J. Kiesel Estate, have been permitted to submit formal proof of claim and testimony showing ownership of lands and the irrigation of same, and ownership of shares of stock in the Owyhee Ditch Company, a corporation. That at the time the above contest was on for hearing, the contestants questioned the priority, diligence, area of land, and quantity of water covered by the claim of contestee Owyhee Ditch Company. Twenty-seven of the forty contestants claim to have acquired water rights prior to the company's right by adverse user. During the taking of testimony and the argument it was stipulated in effect that contestants' use of water had never shortened the supply of water in the company's ditch, and during the argument to the Court counsel for the ditch company admitted that the company would not gain anything by demanding that any of the users above its ditch turn water down, for the distance between the head of the company ditch and the nearest user upon the river was too great for any increase of supply to be acquired by reason of having the same turned down. Therefore, it can not be said that any adverse use has been established by said contestants.

by them and under the company ditch, made co-contestees with the company in the contest, and who are now objectors to the findings, appeared and asserted certain rights adverse to those asserted by the company, and are now asserting adverse rights to those asserted in its formal proof and which have been determined favorably to the company by the State Engineer; their main contention being that they and not the company own the water rights; that date of priority should date from date of application of water to the irrigation of land; that different dates of priority under the ditch should be decreed, and that they should have prior dates over the stockholders who did not commence irrigation of land when they did; that neither the company nor any of the later users should be permitted to demand a proratable distribution of the water appropriated among the users under the ditch during a shortage of water, and that the water rights under the ditch should be decreed to the individuals in their own name, with date of priority as of the date water was first applied to their respective tracts of land.

It appears to the Court from the testimony herein that prior to October 20, 1882. Alex Matheson and H. P. Kriss settled upon government lands which are located under

the company's ditch with the intention of obtaining title thereto and making it their homes, and did, on October 20, 1882, file with the county clerk of the county in which said lands were situated a notice of appropriation of water from Owyhee River for irrigation and other purposes, claiming 10,000 inches of said waters, and proceeded with the construction of a ditch for a distance of about six miles and to a point near what is known as Mitchell Butte, in Township 21 South, Range 45 East, W.M., for the purpose of irrigating the lands they had settled upon and of other settlers who might procure lands under said ditch, and who should acquire an interest in the ditch by helping to construct the same, by working thereon or otherwise; that thereafter they had more or less trouble in maintaining the diversion dam, and that some of the interested parties had lands too high up to be irrigated from said ditch; that Thomas C. Fletcher and Chas. O. Wilson, in 1887, commenced the construction of another ditch, and on August 17, 1887, filed a notice of appropriation claiming 2,000 inches of water, and thereafter and after some construction work had been done on the ditch, by which time quite a number of settlers had become interested in one or both ditches, they all reached an agreement wherein they would thereafter concentrate their efforts on the construction of a larger ditch with its head at the same point settled upon for the 1887 ditch, as it could serve not only all of their lands, but many other settlers who might later settle upon lands that would be under the line of the ditch, which could be extended down some distance below, to the Malheur River. Thereafter, and on October 30, 1888, nine of the interested parties prepared another notice of appropriation and posted the same on the river at the diversion point, claiming 20,000 inches of water to be carried in a ditch 20 feet wide at the bottom, 25 feet wide at the top, and six feet deep. A company was then formed, and on December 21, 1888 was incorporated under the laws of the State of Oregon with a capital stock of \$20,000; that thereupon all of the appropriators of said water and owners of all of said ditches, on February 8, 1889, conveyed all of said rights and interest in said appropriations and ditches to the Owyhee Ditch Company, a corporation, for and in consideration of \$5,000 of its capital stock. Thereupon the company took charge of all of said rights and commenced the construction of said ditch, and by the spring of 1893 had completed about 10 miles of same, and on or about 1897 the ditch was completed to a distance of about 22 miles, to the Malheur River. The dimensions of said ditch for the first 10 miles are, 20 feet wide on the bottom, 32 feet wide on the top, and 6 feet deep. Thereafter its dimensions are reduced at certain intervals, but is considered to be of a sufficient size all the way to carry a sufficient quantity of water to supply all of its stockholders' demands. That in the spring of 1892 it was determined that the company could not complete its ditch with its \$20,000 as first contemplated, and they amended their articles of incorporation by increasing its capital stock to 6,000 shares, of a valuation of \$30,000. This additional stock was sold and this money used on the construction.

In March, 1894, it was determined that more money had to be raised, and the company increased its capital stock to 10,000 shares and raised its value from \$5 per share to \$10 per share, and thereupon proceeded to sell stock from time to time to parties contemplating the use of water, to which its stock showed them to be entitled, and proceeded to the completion of its ditch, in about 1896 or 1897, whereupon they found they were indebted in the sum of about \$50,000. Thereupon 20-year bonds were issued and sold to Fred J. Kiesel, one of its stockholders, which bonds matured in the year 1915, and the company being unable to pay the same, thereupon the old bonds were retired and a reissue of said bonds for the same amount was made, in 1915, and this obligation is now outstanding. That on the 14th day of January, 1895, the company adopted and filed its supplementary articles of incorporation of the Owyhee Ditch Company, and there is contained in subdivision 1 of Article 2, the following, to-wit:

"To appropriate and divert the waters of Owyhee River in Malheur County, State of Oregon, for mining, milling, domestic, and agricultural purposes."

And in subdivision 3:

"To engage in agricultural, mining, milling, and manufacturing pursuits and to sell, rent, or distribute said waters to the stockholders of the corporation and to all persons owning lands adjacent to or within reach of the line of said ditch, for the purpose of irrigation, household, or domestic consumption, and watering livestock and dry lands of the State of Oregon."

And in subdivision 4:

"To fix and collect rates for the use of said water; and collect such fees upon the stock as may be necessary for the maintaining of said ditch."

And in Article 6:

"Each water right represented by each share of stock shall be entitled to its proportionate amount of water flowing through the ditch or canal; provided, that said proportion shall not exceed that quantity of water equal to one inch, measured under a six inch pressure, miners' measurement."

Article 7 provides:

"In consideration of the water right attached to each share of stock, the capital stock subscribed as provided herein to this corporation, at any time, after it has been so subscribed, shall be liable to an assessment not to exceed five per cent per annum upon the par value thereof. The proceeds of such assessment shall be used to pay the necessary expenses of running and operating the ditch or canal, making repairs, etc., and such other obligations as may necessarily be incurred."

Article 11 reads as follows:

"No water right shall be procured from this corporation, other than that represented by the stock."

An appropriator of water is entitled to a reasonable length of time to complete his ditch or other means of carrying the waters to the place of use, and thereafter is entitled to a reasonable length of time in which to actually apply the water to beneficial use upon the lands. The purchasers of shares of stock, and who are entitled to receive water from the company in accordance with their stock interest, were in the main persons of limited means, and were new settlers upon new and unimproved lands,

and the record shows that said stockholders have received water from the company and have heretofore irrigated and had in cultivation from time to time approximately 15,000 acres of the lands under said ditch. It further appears that all of said 15,000 acres are not, and have not been irrigated each and every year, several hundred acres having become waterlogged, and the owners of such lands have been and are now expending large sums of money to drain the waterlogged lands, and when the same are reclaimed the owners are entitled to receive water for the irrigation of the same in proportion as their stock interests show them to be entitled to. Other tracts of land have not been irrigated each and every year for one reason or another known to the individual owner, but none of the owners of stock who have heretofore irrigated their lands have abandoned any of their rights, as each share of stock has been assessed annually and all in an equal amount, which same, together with the acreage charge upon which water was used for the current year, was and has been used by the company in paying its current obligations and carrying on its business.

It further appears that at the time set for the submission of proof of claims to the State Water Board, the company failed to submit any proof of claim for waters for the lands under said ditch, falling to the heirs of Fred J. Kiesel, deceased, nor was there submitted any individual, proof of claims for the same; and upon hearing had and testimony submitted herein, it appears that since the construction of said ditch practically all of said lands at one time, together with some other lands owned by the K. S. D. Fruit Land Company, had been in a high state of cultivation, and later became waterlogged and have been and now are being reclaimed by a system of drainage; and it further appears that some of the K. S. D. land and all of said lands belonging to the heirs of Fred J. Kiesel, deceased, were emitted from the tabulation of irrigated lands. It is hereby ordered that said parties shall have three years from the entry of this dea rest to complete the reclamation of said waterlogged lands. At the expiration of said time the State Engineer shall make a survey of the lands reclaimed in each legal subdivision and include all of the irrigated lands in his Certificates of Water Right.

> It further appears that 28 years have elapsed since the completion of the Owyhee Ditch, and that the period above specified is a reasonable time to be allowed claimants for the application of said water to beneficial use through its stockholders owning lands thereunder, and the date of priority for the waters for the irrigation of approximately 15,000 acres is hereby allowed as of October, 1888.

It is further ordered that the quantity of water which may be diverted for the irrigation of lands under said ditch shall be governed by the provisions of Paragraph 24 herein.

It further appears that during some seasons there is a shortage of water in the Owyhee River to meet the demands of the stockholders, and in addition to said diversion the company has had to install a pumping plant on the Snake River to supplement its supply from Owyhee River. The date of priority for this supplemental supply shall be governed by the water right granted by the State Engineer of the State of Oregon.

It further appears that the water right perfected by the company under the appropriation of October 30, 1888, was perfected to cover all lands under the ditch, and all stockholders who have applied the water to beneficial use upon the said 15,000 acres, and shown to be entitled to water under said system shall be entitled to the same proportion of water available for the entire area, and shall bear equally in any shortage of water that may occur.

It further appears that some land owners have heretofore produced water from the company and irrigated lands, who were not stockholders in the company, and others who did not own sufficient shares of stock to entitle them to the quantity of water necessary for the irrigation of the quantity of land being irrigated. As to such persons the order herein making the water appurtenant to lands heretofore irrigated, whereby such lands are ordered to share a proportionate part of the water during a shortage, shall not operate to vest such rights, and in case of a shortage of water the company shall cease furnishing water for such lands during the period of shortage.

It further appears to the Court that there are owners of shares of stock who have not so far availed themselves of the right to demand the delivery of water and put it to beneficial use in the irrigation of their lands. As to such stockholders, as are the purchasers of any unissued stock, in the event that they see fit to demand water for irrigation or other use, the use shall be, and it is hereby declared to be inferior to the rights herein established, and as to such persons, they shall not be permitted to share in the water during a period of shortage.

EXCEPTION NO. 3426

That the contestee in this contest filed claim for water right from Jordan Creek with priority of 1891 for 186 acres of land, part of which has not been irrigated, but for which an incheate right is claimed. Contestant and objector questions the priority and extent of the claim. It appears that construction work was commenced on contestee's ditch in the year 1891, and 2½ miles, extending to the Owyhee River, was completed by 1898, where some small patches of land aggregating about 14.4 acres were irrigated. In the beginning of the ditch construction the main object was to irrigate land across the Owyhee River. This was abandoned on account of excessive cost of completion, until about 1906, when arrangements were made with the county court to use the county bridge therefor, and in 1909 about 35 acres of new land was irrigated. By reason of the abandoning the work

from 1898 until 1906, contestee is entitled to date of priority of 1891 for 14.4 acres in Sections 13 and 14, and date of priority of 1906 for the remainder of his irrigated lands in said sections.

That contestee's land at the lower end of his ditch in Section 10 was filed upon some time between 1901 and 1903, and water was first applied to said lands in the year 1915, and his date of priority for 38.5 acres in Section 10 shall be of date 1915. It is further ordered that the tabulation of the State Engineer be changed to conform with the dates of priority above mentioned.

Contest No. 6

Short Line Ditch Company, and R. R. Overstreet,

Contestants.

vs.

W. W. Smith.

Contestee.

That the main issue involved in this contest was the effect of the moving of contestee's point of diversion. The contestee and his predecessors had, since about 1884, diverted water from Owyhee River through what is known as the Collins Ditch, but in 1920 the point of diversion was changed to a point about three miles down stream where the water was diverted by means of a pump. Prior to the year 1920, the contestants filed applications with the State Engineer, and received permits for the appropriation of the waters of the Owyhee River for irrigation, their points of diversion being below the present pumping plant of Contestee. It is contended by the contestants that contestee is now able to pump more water than he could divert formerly at the Collins dam, on account of certain accretions from seepage and waste water coming into the stream between the Collins dam and the present diversion.

The rule has been established by our Courts that an appropriator may change his point of diversion at any time, providing such change does not work an injury on the rights of others. It would seem that the change involved herein could be made without interfering with the rights of contestants, and that contestee should be allowed to make the change and retain his priority, but that his rights should be limited to the same extent as they were when the water was diverted through the Collins ditch.

That after the initiation of Contestee's right in 1884, there had been a gradual increase in the amount of land reclaimed and irrigated, until at the time of filing the claim in 1921 there were approximately 90 acres of contestee's land under irrigation. That a sufficient length of time has elapsed for the completion of this right, and that contestee should be limited to sufficient water for 90 acres, under priority of 1884, and that the right for any additional acreage should be covered by a filing

made with the State Engineer. That under the former method of diversion of the water through the Collins ditch there was considerable loss of water by seepage and evaporation, and through breaks and gopher holes in the ditch, and that practically all of such losses have been eliminated by pumping the water from the river directly onto the land. That contestee shall be entitled to pump from the river at his present diversion, the same amount of water that he could have diverted at the head of the Collins ditch under the former conditions, and shall at no time pump more water at his present place of diversion than the quantity that would be available to him at the head of the Collins ditch at that particular time. And the amount of water to which contestee shall be entitled for the irrigation of said 90 acres of land shall also be limited by the provisions of Paragraph 24 hereof.

Contest No. 7

L. R. Duncan.

Contestant and Exceptor,

VS.

Fred J. Palmer and W. S. Skinner,

Contestees.

Contestant challenges the date of priority and acreage of contestee Fred J. Palmer for water from Cow Creek. At the hearing it was stipulated between contestants and contestee Palmer, wherein contestee conceded a superior right in contestant, save and except for 15 acres of Palmer's land irrigated through the Garden Ditch. This being about the extent of the lands upon which water from Cow Creek has been used by the said Fred J. Palmer, his claim is allowed a date of priority of 1885 for 15 acres.

The contestant further challenges the date of priority of contestee W. S. Skinner for water of Cow Creek to irrigate 710 acres of lands as of 1906, or any other date earlier than 1909. The said W. S. Skinner, Fred J. Palmer and Hal Parks, owners of the Beers Skinner High Line ditch, diverting water from Cow Creek, are hereby decreed a right to divert waters from Cow Creek through the head of the Garden Ditch and carry it down the Garden Ditch some two or three hundred feet to the head of the Beers Skinner High Line Ditch for the irrigation of 710 acres of their lands as hereinafter tabulated, with date of priority of 1908.

Contest No. 8

James P. Anderson,

Contestant,

Pacific Livestock Company,

Contestee.

This contest was settled by a stipulation, as follows:

"Whereas there is now pending before the State Water Board a proceeding for the adjudication of the relative rights to the use of the waters of the Owyhee River, in Malheur County, Oregon, and

Whereas a contest has been filed by James P. Anderson, contesting the rights claimed by the Pacific Livestock Company, a corporation, to the use of the waters on Crooked Creek, a tributary of said Owyhee River, and

Whereas the relative rights of these parties and their predecessors in interest have been, to a large extent, determined by the Supreme Court of the State of Oregon in that certain case entitled J. H. Seaweard, et al, against the Pacific Livestock Company, reported in 49 Oregon Reports, at page 157, and the case of Seaweard against Duncan, reported in 47 Oregon Reports, at page 640, and in which first mentioned case the Court made a final decree awarding to the Pacific Livestock Company the right to the use of 100 miners inches of water, measured under a six inch pressure, to be taken from said Crooked Creek, said right to be prior in time to the other users mentioned in said decree, and the Court made a decree in awarding to J.H. Seaweard 120 inches, to Anderson Loveland 150 inches, and to P. O. Duncan 80 inches, and

Whereas the said James P. Anderson has succeeded to the rights of the said Seaweard, Loveland and Duncan, and is now the owner of the lands and water rights of said parties, and these parties are now willing that such decree should control the amount of water awarded to each of the parties herein:

NOW, THEREFORE, it is agreed that the State Engineer's office, in its findings and decree to be made and entered in this matter should find that the said Pacific Livestock Company shall have a prior right to the use of the waters of Crooked Creek to the extent of 100 miners inches, measured under a six inch pressure, to be used as it sees fit on the lands of said company in the Southwest quarter and the Southeast quarter of Section 14, and its lands in the Northeast quarter of Section 22, Township 33, S. R. 39 E. W. M., and that the said James P. Anderson shall be entitled to the use of 350 miners inches of water, measured under a six inch pressure, for the irrigation of his lands in Sections 20, 17 and 4 in Township 33, South, Range 40 E. W. M.

Except as to the prior right of said Pacific Livestock Company to said 100 inches, this stipulation is not to affect any right that the said James P. Anderson might have to the use of said waters by virtue of any permits from the office of the State Engineer for the use and storage of said waters of Crooked Creek.

IT IS FURTHER AGREED that as to the waters rising on the lands of said Anderson in Section 15, Township 33 South, Range 39 E. W. M., that said water shall be used by both parties in the future as same have been in the past, and that neither party shall make nor attempt to make any use of said waters that will take the said waters away from the premises of the other party as the same are now used.

This agreement is made in consideration of the mutual benefits that a settlement of the issues may be to each of said parties, and that in consideration thereof, the said contest herein mentioned may be dismissed."

In the administration of the water rights allowed herein to the parties to this contest, and their successors in interest, the water master shall distribute the water as between said parties in accordance with the terms of said stipulation and the decree mentioned therein, insofar as practicable; provided, that the quantity of water used by said parties shall be governed by Paragraph 24 hereof; and provided further, that as against other water users the rights of said parties shall be governed by their dates of priority as set forth in the tabulation hereinafter contained.

Contest No. 9

James A. Ditton.

Contestee.

That this contest was set down for hearing, and the parties appeared and entered into a stipulation, which appears on page 481 of the testimony. By the terms of said stipulation Contestee Maude Haylett is to have an equal right with Contestant for $9\frac{1}{2}$ acres irrigated through the Shea ditch, and an inferior right to Contestant for a second $9\frac{1}{2}$ acres irrigated through said ditch; and Contestee's other rights from Cow Creek are to be inferior to Contestants. The rights of said parties have been tabulated in accordance with said stipulation.

21.

That J. B. McCain filed claims in this proceeding, for water rights from Cow Creek after the period fixed for public inspection of claims had expired. Said McCain at the time of filing such claims gave due notice thereof by registered mail to all other claimants to water from Cow Creek, and said claims were held open to inspection and subject to contest at the hearings on other contests filed herein. That no contests were filed against said claim, but during said hearings a stipulation was entered into modifying the rights claimed by said J. B. McCain, as follows:

It is hereby stipulated by and between James A. Ditton, and J. B. McCain, that

Whereas the said J. B. McCain has recently filed his proof of claim in this matter, claiming priorities for the use of water from Cow Creek as of March 18, 1885, and that

Whereas said proofs of claim having been filed at this time are subject to contest, and said James A. Ditton objects to said priorities, therefore it is stipulated, for the purpose of adjusting said priorities that the said J. B. McCain should have a priority as of 1886, and of equal date with the said James A. Ditton for the Purser-Shea ditch of the said James A. Ditton, for all of the following ditches of the said J. B. McCain, to-wit:

Purser-Shea ditch for the irrigation of lands in Section 27, the Hart Desert ditch for the irrigation of lands in Sections 27 and 28, the Hart No. 8 ditch for the irrigation of lands in Section 28, the Hart No. 7 ditch for the irrigation of lands in Section 28, the Baltzor and McConnell ditch for the irrigation of lands in Section 28, the Purser-Shea and Hart No. 4 ditch for the irrigation of lands in Sections 27 and 28, and the Garden ditch for the irrigation of lands in Section 28, and the Hart No. 6 ditch and slough for the irrigation of lands in Section 28, all of said lands being in T. 28 S. R. 46 E. W. M., that as to all of the above described lands, they should have an equal priority as aforesaid, with the lands of James A. Ditton, being 1886, the same priority as claimed by said Ditton for lands in Sections 23, 26, and 27, T. 28 S. R. 46 E.

And the rights of said claimant J. B. McCain are tabulated in accordance with said stipulation.

That an agreement was filed between L. R. Duncan and Pascual Liguren as follows:

"This agreement, made and entered into this 26th day of May, 1923, by and between Pascual Eiguren and L. R. Duncan, both of Jordan Valley, Oregon, WITNESSETH:

That whereas, Pascual Eiguren is the owner of certain lands in Sections 26, 27, 34 and 35, T. 30 S. R. 42 E. W. M., and L. R. Duncan is the owner of certain lands in Sections 10, 11, 14 and 15, T. 31 S. R. 41 E. W. M., and

Whereas, said lands of both parties are irrigated from and by the waters of Jordan Creek and of Cow Creek, a tributary thereof; and

Whereas, during the later part of the irrigation season of each year the flow of water of said streams become low and there may in some years not be enough water in said streams to equal the amount of the appropriation of each of said parties; and

Whereas, it would be impossible under such conditions to fulfill the requirements for irrigation of both of said appropriators; and

Whereas, by reason of the long distance between the lands of the two said parties, the nature of the stream bed and other difficulties, it is not deemed to be feasible to rotate the use of said waters;

NOW, THEREFORE, in consideration of the mutual benefit, the settlement of the difficulties and other valuable considerations, it is hereby mutually agreed by and between the said parties hereto, that whenever the flow of said streams becomes so low that by reason of prior appropriation and of the flow of said streams, the appropriation allotted and decreed to L. R. Duncan cannot be filled, then that the amount of water flowing in said streams that reaches the point of diversion of the ditch of the said Pascual Eiguren shall be divided between the said parties at the diversion point of said ditch, the said Pascual Eiguren to receive two-thirds of the said water, the said L. R. Duncan to receive one-third of the said water continuous flow so long as the said water continues to flow to the said point of diversion of the said ditch of the said Pascual Eiguren.

THIS AGREEMENT shall bind each of said parties and their heirs, successors or assigns, and is made to become a part of the findings of the Water Board of the State of Oregon and of the decree of the Court to be made herein, determining this matter of the adjudication of the relative rights to the use of waters of the Owyhee River and its tributaries.

IN TESTIMONY WHEREOF, the said parties hereto have hereunto set their hands and seals on the day and date first hereinabove written.

In the distribution of water on Jordan Creek, this agreement shall be enforced so long as the rights of other parties are not thereby interfered with, but in such
event the water shall be distributed in accordance with the relative priorities of the
rights of said parties.

23.

That the Owyhee River rises in the southwestern part of the State of Idaho, and flows in a general northerly direction through Malheur County in the southeastern portion of the State of Oregon, becoming tributary of the Snake River near Nyssa, Oregon.

The area drained by said stream and its tributaries comprises some 11,000 square miles of

rolling or broken sage brush land, which is devoid of timber except at the extreme head-waters. About 13 miles from its mouth the stream emerges from a narrow canyon into the Snake River Valley, in which the major portion of the irrigated lands is situated. About Snake River Valley, there are small areas of irrigated lands where the canyons widen out in places and form small valleys, and a considerable area in the wider valley of Jordan Creek, a tributary rising in Idaho and flowing westerly to its junction with the main river about midway in its course. The lands irrigated from Jordan Creek are mostly contained in two comparatively level valleys, with an area of some 8,000 acres across which the stream flows through numerous channels and sloughs.

That the lands irrigated from Owyhee River and its tributaries are arid lands, and require artificial irrigation for the raising of profitable crops. The crops raised on the lands in the Snake River Valley, and on the lower end of the stream, consist of alfalfa, clover, orchards, grain and various kinds of vegetables. On the upper parts of the stream and particularly on Jordan Creek, the main crop is wild meadow hay, with some hardy root crops, alfalfa and grain.

24.

That the rights to the use of water from Owyhee River and its tributaries as herein determined shall be limited to the diversion of the amount of water which can be applied to beneficial use, and shall be further limited as follows:

The amount of water diverted from main Owyhee River for irrigation purposes shall not exceed one acre foot per acre during any calendar month prior to June 1st, and three-fourths acre foot per acre during any calendar month after June 1st, of each year; and the total quantity diverted during the irrigation season from April 1st to October 15th, shall not exceed three acre feet per acre.

early run-off of the waters they have always flooded their irrigated lands with great quantities of water, and that this system is necessary to insure a crop, and that such use of water of said stream through this period deprives no one of ample water, as there is always a surplus and some to spare until June 1 or 10 of each year, and in addition to properly supply the needed use, the effect is to reservoir this water in the saturated ground, thereby holding up the run-off of the stream for a longer period, and adding to the late waters in the Owyhee River.

The amount of water diverted from the tributaries of Owyhee River for irrigation purposes shall be limited to two acre feet per acre prior to June 1 of each year, and thereafter, during each irrigation season, there shall not be diverted for irrigation purposes water in excess of one-half acre foot per acre during any calendar month of each year; provided, that as to Jordan Creek proper, willow and ryegrass lands (hereinafter tabulated) heretofore irrigated and included in proofs of claims but ex-

cluded by the tabulation of the State Engineer may receive not in excess of two acre feet per acre each year prior to June 1, and shall not receive water thereafter; and provided further, that no greater quantity of water shall be used for any such lands for irrigation than the crops or other products grown thereon may require for the proper irrigation thereof.

The water users herein, or any group of users may notify the water master of their district in writing that they desire to use the water appurtenant to their lands by rotation. The water master shall take charge of said water and arrange such system or systems of rotation as may be for the best interest of all concerned.

That in case the water flowing in the channel of a stream sinks, or fails to flow down the channel so as to be of beneficial use to the appropriator having the prior right, and it is being lost, the water master shall allow the same to be diverted by the next in order of priority who can make beneficial use of the same.

25.

That all parties herein allowed a right to the use of water for irrigation shall be entitled to use such water for stock and domestic purposes, and the right of use of water for stock and domestic purposes as hereby confirmed entitles the owner of such right to divert and use such a quantity of water as is reasonably necessary for his domestic and household use and for stock purposes; that the right to divert and use water for stock and domestic purposes shall continue throughout the year. That outside of the irrigation season, the amount so diverted and used shall not exceed the rate of one-fortieth of one cubic foot per second for each one thousand head of stock, but during the irrigation season appropriators of water for irrigation purposes shall not be entitled to divert any water for stock and domestic purposes in addition to the amount which they are entitled to divert for irrigation purposes.

26.

That the rights to the use of water for irrigation purposes hereby confirmed are appurtenant to the lands herein described, and the rights of use of the waters of said stream and its tributaries by virtue of such rights are limited and confined to the irrigation of the lands described herein to the extent of said lands herein set forth, and the priorities of right herein confirmed confer no right of use of the waters of said stream and its tributaries on any lands other than those specified tracts to which such rights are herein set forth as appurtenant, and each and every person shall be and hereby is prohibited, restrained, and enjoined from diverting and using water from said stream on such other lands without lawful permit first obtained from the State Engineer.

That except as otherwise determined herein, the order of the rights of the respective appropriators of the waters of said stream and its tributaries, and in which order they are entitled to divert and use the said water shall be and is according to the date of the relative priority of the rights as herein set forth and determined, and the first in order of time according to the date of relative priority shall be and is the first in order of right, and so on down to the date of the latest right, and those having prior rights are entitled to divert and use the waters of said stream and its tributaries when necessary for beneficial use in connection with the irrigation of their respective lands or other useful and beneficial purposes for which they are decreed the right of use, at all times against those having subsequent rights without let or hindrance, and whenever the water is not required by the appropriator having a prior right to its use for the purpose for which said water was appropriated, he must and shall permit it to flow down the natural channel of the stream as it was wont to flow in its natural course without hindrance or diversion thereof, and those having subsequent rights are entitled to the use of such water and to divert the same to the extent of their rights of appropriation according to the order of priority of their rights; and at all times the waters shall be beneficially, economically and reasonably used without waste by those having a right to the use of such water, and no rights of appropriation are hereby confirmed to divert a greater quantity of water into the head of the ditch or ditches of the appropriator having valid right to divert water than such appropriator can beneficially use for the purpose to which the water is to be put.

28.

That each and every appropriator holding a permit or permits occurring the right to appropriate water from said Owyhee River or its tributaries, whether a claim thereunder was filed in this proceeding or not, shall have such water rights thereunder as are provided by law, and the rights of such parties shall be completed and established in the manner provided by law for the completion of such rights. That the rights of each and every appropriator holding a water right certificate or certificates covering a right to appropriate water from said Owyhee River or its tributaries, whether a claim thereunder was filed in this proceeding or not, shall be as defined and limited in such certificates, except where such rights have been abandoned subsequent to the issuance of the certificate.

EXCEPTION NO. 3433

It appearing to the Court that Thomas Brothers have filed their petition asking to have the order of determination herein amended so as to decree to them a right to use the waters of Dry Creek to irrigate 120 acres instead of 80 acres allewed

to them herein; their proof of claim shows that in 1905 the land was cleared for plow, in 1906 the ditch was constructed, in 1907 about 20 acres were irrigated, and at the time of preparing the proof of claim, they had 80 acres in cultivation. It appears to the Court that they have not shown due diligence, and by reason thereof their petition be, and the same hereby is dismissed.

30.

It further appears to the Court that Chevalley Brothers have filed their exception to the tabulation, same being Exception number 3403. A motion has been made by the above named claimants asking permission to smend their original proofs of claim in certain respects, as said proofs appear on pages 1208, 1213, 1214, 1218, and 1222 of Volume 4. It is hereby ordered that said motion be, and the same is hereby allowed.

The above named claimants have also filed their exceptions to the order of determination of their rights as tabulated on page 68, in that the same fails to award any water of Spring Creek through Spring Creek Ditch for the irrigation of lands in Section 19, Township 28 South, Range 46 E. W. M., and fails to award any water of Thomas Creek and Cow Creek through the Prince Athern Ditch for irrigation of certain lands in Section 19, T. 28 S. R. 46 E. W. M. Also excepts to the acreage allowed through the Baltzor Ditch from Cow Creek, and the acreage allowed through the McConnell Ditch from Cow Creek and Thomas Creek.

And it appearing to the Court from the proof of claims that claimants have cultivated and irrigated 225.4 acres of land in Section 30, Township 28 South, Range 46 E. W. M., through the Baltzor Ditch from Cow Creek, under date of priority of 1897, and have cultivated and irrigated 335 acres of land in Sections 19 and 20, Township 28 South, Range 46 E. W. M., through the McConnell Ditch from Cow Creek and Thomas Creek, under date of priority of 1899, all not being shown as tabulated in said proofs of claim, it is hereby ordered that said tabulation shall be corrected to show the said 225.4 acres and the said 335 acres.

It is further ordered that the said tabulation shall be amended to include the irrigation of 120 acres in Section 19, Township 28 South, Range 45 E. W. M., through the Prince Atherns Ditch with date of priority of 1884.

That since the filing of exceptions by claimants there has been filed herein a stipulation in effect admitting a prior right of Exir Frank Baltzor, owner and claimant, to any and all water of Spring Creek and all waters tributary thereto for the purpose of irrigation, stock, and domestic use. It is ordered that said claimants have a right for irrigation, stock, and domestic purposes from Spring Creek through Spring Ditch with a date of priority of 1884, subject to prior and superior rights of the said

Exir Frank Baltzor, for 40 acres in the NE SW4 and 20 acres in the SE4SW4 Section 19, Township 28 South, Range 46 E. W. M. It is further ordered that the tabulation of the State Engineer be changed to show such superior and prior right in said Exir Frank Baltzor.

31.

Claiment H. C. Dumagan has filed his exception number 2404 to the acreage allowed to him in the tabulation of the State Engineer, as the same appears on page 69 of said determination; and it appearing to the Court from the proof of claim filed herein that some years a portion of claimant's lands are summer-fallowed, but that 339.5 acres of his lands in Section 29, Township 28 South, Range 46 E. W. M., have been cultivated and crops grown thereon and the same irrigated by waters from Cow Creek since 1888, that a portion thereof was in summer-fallow during the survey by the State Engineer in 1920, and that his lands in the Masse of said section were and have been irrigated from said creek under the date of 1888 right, it is ordered that the rights of said claimant shall be as hereinsfter tabulated.

32.

It further appearing to the Court that claimants Thomas Cowgill and William Cowgill have filed their Exception number 3410 to the order of determination filed herein and have duly served a copy of such exceptions upon all claimants calculated to be affected by the changes asked for in said determination, and no objection being made to the allowance of same, it is ordered that the dates of priority of 1887 and 1888 as allowed and tabulated be changed to dates of priority of 1865.

33.

It is further ordered that as to the successors in interest of Samuel Fretwell, Annie Nichols, Carleton Fretwell, and Lucy Staples, the tabulation on page 58 of the order of determination of lands described as being in Section 4, Township 30 South, Range 46 E. W. M., be changed to Section 5.

34.

It is further ordered that the tabulated date of priority allowed W. S. Skinner for the irrigation of his land in Section 24, Township 30 South, Range 44 East, W. M., as the same appears on page 63 of said order of determination, be changed to date of priority of 1869.

35.

It is further ordered that the tabulated date of priority allowed Lasaro Urguiaga for 26.1 acres in SENET Section 1, Township 31 South, Range 42 East, W.M., as appears in lines 40 and 41 on page 65 of said determination, be changed to date of priority of 1902.

It further appearing to the Court that claimant Fred J. Palmer filed his exception number 3428 herein, wherein he objects to date of priority allowed, mainly through the Beers Ditch for the irrigation of his land in Sections 15, 16, 21 and 22, Township 30 South, Range 44 East, W. M., and it appears to the Court from the examination of his proof of claim, the same being on pages 1059, 1060, and 1061, and 1062, that on or about 1870, ____ Enskeep settled at or near the mouth of Cow Creek on what is known as the Ruby Ranch, embracing lands described therein, and about said time diverted the waters from Jordan Creek for irrigation of lands of his, and his successors in interest. W. P. Beers, about 1874 constructed a dam in the MWANWA Section 26 and completed the same about 1879, shortly after a dam was constructed in the SELWE of Section 22, for the irrigation of lands south of Jordan Creek, and in his testimony on page 586 he says: For his land on the north side of the creek water is diverted in Section 26 into a slough that enters the southeasterly parts of Section 22, and there he takes it into a ditch that is about a mile and three-fourths long that irrigates all of the land. The lands on the south of the creek are meadow lands. On page 587 he says: A good part of the lands on the north side, before his time, was irrigated from Goose Ranch Slough. (This must be the slough that enters the southeasterly part of Section 22.) On page 589 he says he doesn't know when the lands in Section 15 were cleared and put to cultivation, and on page 590 he says that he thinks that some 15 or 18 years ago a part of Section 15 was in cultivation. It is further ordered that the tabulation of the date of priority awarded the claimant for lands in Section 22, Township 30 S. R. 44 H. W. M., as of date of 1888, as the same appears in line 16 on page 62, be changed to date of priority of 1874.

37.

It appearing to the Court that claimant Jordan Valley Mercantile Company has filed its exceptions, number 3429, to the acreage allowed in the tabulation of the State Engineer, and it appearing to the Court that claimant has heretofore irrigated 110.1 acres and had been at the time of taking testimony, it is hereby ordered that the acreage tabulated on page 71 as being the property of claimants be changed as hereinafter tabulated.

38.

That except as otherwise modified herein, the rights of the various appropriators of water from Owyhee River and its tributaries, arranged in tabulated form, with the dates of relative priority of such appropriations, the number of acres to which such appropriations are applied and are now limited, the use or uses for which said water was applied, the name of the ditch or other means by which the water so appropriated has been diverted, the name of the stream or other source from which the water has been used, and the description of the lands upon which the water has been used, the tabulated rights of each appropriator being set opposite and following his name and postoffice address, are
