DECREE
AFFIRMING THE SUPPLEMENTAL FINDINGS OF FACT AND ORDER
OF DETERMINATION OF THE STATE ENGINEER

The State Engineer of Oregon, having heretofore made his supplemental findings of fact and order of determination herein, determining and establishing the right of Opal Jarvis to the use of the waters of Cow Creek, and there having been filed with the Clerk of this Court on the 29th day of April, 1942, the original evidence filed with the State Engineer and a copy of the supplemental findings of fact and order of determination of said State Engineer as the same appears of record in his office, and said State Engineer having thereupon procured from this Court an order fixing June 13, 1942, as the time at which the determination herein would be heard by this Court, and notice of said hearing and the time fixed therefor having been duly and regularly given, in the manner required by law, to each claimant claiming a right to the use of the waters of Cow Creek through the Cow Creek Irrigation Company Ditch, and it appearing to this Court that no objections or exceptions thereto have been filed herein, and this Court having duly considered the matter finds that said supplemental findings of fact and order of determination of the State Engineer determining the right of Opal Jarvis to the use of the waters of Cow Creek and its tributaries should be affirmed.

It is therefore hereby CONSIDERED, ADJUDGED AND DECREED by this Court that the supplemental findings of fact and order of determination of the State Engineer in the matter of the determination of the relative rights to the use of the waters of Cow Creek and its tributaries, a tributary of the South Fork of Umpqua River, be and the same are hereby affirmed.
